The Big Spring Firemen's Relief and Retirement Fund Board of Trustees held a regular called meeting on Thursday, June 9, 2022 at 9:00 a.m. at the Big Spring City Council located at 307 East 4<sup>th</sup> Street, Big Spring, Texas 79720, pursuant to notice.

**PRESENTATIONS BY RASTEGAR AND TERRACAP MANAGEMENT, LLC:** The Board reviewed presentations from Rastegar and TerraCap Management, LLC. The firms provided an overview of their respective firm profiles, investment strategies, current holdings and answered all questions from the Board. The Board discussed minimum investment amounts required by each firm. Further discussion will be held at the next regular meeting.

**REVIEW/APPROVE – LAUTERBACH & AMEN, LLP MONTHLY FINANCIAL REPORTS:** The Board reviewed the Monthly Financial Report for the medical subsidy fund for the four-month period ending April 30, 2022 prepared by L&A. As of April 30, 2022, the net position held in trust for pension benefits is \$677,888.96 for a change in position of (\$97,813.44). The Board also reviewed the Cash Analysis Report, Revenue Report, Expense Report and the Vendor Check Report for the period April 1, 2022 through April 30, 2022 for total disbursements of \$2,664.33.

The Board reviewed the Monthly Financial Report for the retirement fund for the four-month period ending April 30, 2022 prepared by L&A. As of April 30, 2022, the net position held in trust for pension benefits of the retirement fund is \$15,110,144.52 for a change in position of (\$1,904,026.66). The Board also reviewed the Cash Analysis Report, Revenue Report, Expense Report and the Vendor Check Report for the period April 1, 2022 through April 30, 2022 for total disbursements of \$4,177.24.

A motion was made by Trustee Smith and seconded by Trustee Pederson to accept the Monthly Financial Reports as presented and to approve the disbursements shown on the April 1, 2022 through April 30, 2022 Vendor Check Reports in the amounts of \$2,664.33 and \$4,177.24. *Trustee Training Registration Fees and Reimbursable Expenses:* The Board reviewed TEXPERS invoice #8168 in the amount of \$100 for Trustee Sparks' conference registration fee.

The Board reviewed Chairman Delk's reimbursement request in the amount of \$662.81 for the following expenses incurred during attendance at the TEXPERS Annual Conference:

- \$320 for per diem at the rate of \$64 for five days
- \$342.81 for mileage at the rate of \$0.585/mile x 586 miles

*L&A Invoice for Monthly Services:* The Board reviewed L&A invoice #66427 dated May 20, 2022 in the amount of \$1,955 for professional services rendered in the month of April.

*Medical Subsidy Fund Reconciliation – Review/Approve – 2022 Offset Payment to City:* The Board noted that medical subsidy payments were remitted incorrectly in the monthly amount of \$495 instead of \$530 for the period January 1, 2022 through May 31, 2022 and reviewed a matrix provided by the City Finance Department totaling \$875 for adjustments to five retiree medical subsidy payments.

A motion was made by Vice Chairman Brown and seconded by Trustee Cevallos to approve the reimbursement requests, payment of the additional invoice and to direct L&A to authorize Frost Bank to remit \$875 to the City as discussed. Motion carried by roll call vote.
