**REVIEW/APPROVE – LAUTERBACH & AMEN, LLP MONTHLY FINANCIAL REPORTS:** The The Board reviewed the Monthly Financial Report for the Medical Subsidy Fund for the three-month period ending March 31, 2023 prepared by L&A. As of March 31, 2023, the net position held in trust for pension benefits of the retirement fund is \$702,830.61 for a change in position of \$30,949.24. The Board also reviewed the Cash Analysis Report, Revenue Report, Expense Report and the Vendor Check Report for the period March 1, 2023 through March 31, 2023 for total disbursements of \$3,728.83.

The Board also reviewed the Monthly Financial Report for the Retirement Fund for the three-month period ending March 31, 2023 prepared by L&A. As of March 31, 2023, the net position held in trust for pension benefits of the retirement fund is \$14,801,623.01 for a change in position of \$593,555.22. The Board also reviewed the Cash Analysis Report, Revenue Report, Expense Report and the Vendor Check Report for the period March 1, 2023 through March 31, 2023 for total disbursements of \$551.83.
