The Big Spring Firemen's Relief and Retirement Fund Board of Trustees held a regular meeting on Thursday, November 9, 2023 at 8:30 a.m. at the Big Spring City Council located at 307 East 4<sup>th</sup> Street, Big Spring, Texas 79720, pursuant to notice.

**APPROVAL OF MEETING MINUTES:** October 12, 2023 Regular Meeting: The Board reviewed the October 12, 2023 regular meeting minutes. **REVIEW/APPROVE – LAUTERBACH & AMEN, LLP MONTHLY FINANCIAL REPORTS:** The Board reviewed the Monthly Financial Report for the Medical Subsidy Fund for the nine-month period ending September 30, 2023 prepared by L&A. As of September 30, 2023, the net position held in trust for pension benefits of the retirement fund is \$712,815.48 for a change in position of \$40,934.11. The Board also reviewed the Cash Analysis Report, Revenue Report, Expense Report and the Monthly Disbursement Report for the period September 1, 2023, through September 30, 2023 for total disbursements of \$3,728.92.

The Board also reviewed the Monthly Financial Report for the Retirement Fund for the nine-month period ending September 30, 2023, prepared by L&A. As of September 30, 2023, the net position held in trust for pension benefits of the retirement fund is \$14,888,721.89 for a change in position of \$680,654.10. The Board also reviewed the Cash Analysis Report, Revenue Report, Expense Report and the Monthly Disbursement Report for the period September 1, 2023 through September 30, 2023 for total disbursements of \$6,544.03.
