The Big Spring Firemen's Relief and Retirement Fund Board of Trustees held a regular meeting on Thursday, October 12, 2023 at 8:30 a.m. at the Big Spring City Council located at 307 East 4th Street, Big Spring, Texas 79720, pursuant to notice.

REVIEW/APPROVE – LAUTERBACH & AMEN, LLP MONTHLY FINANCIAL REPORTS: The Board reviewed the Monthly Financial Report for the Medical Subsidy Fund for the eight-month period ending August 31, 2023 prepared by L&A. As of August 31, 2023, the net position held in trust for pension benefits of the retirement fund is \$737,563.24 for a change in position of \$65,681.87. The Board also reviewed the Cash Analysis Report, Revenue Report, Expense Report and the Monthly Disbursement Report for the period August 1, 2023, through August 31, 2023 for total disbursements of \$4,644.44.

The Board also reviewed the Monthly Financial Report for the Retirement Fund for the eight-month period ending August 31, 2023, prepared by L&A. As of August 31, 2023, the net position held in trust for pension benefits of the retirement fund is \$15,481,718.03 for a change in position of \$1,273,650.24. The Board also reviewed the Cash Analysis Report, Revenue Report, Expense Report and the Monthly Disbursement Report for the period August 1, 2023 through August 31, 2023 for total disbursements of \$16,405.26.

A motion was made by Trustee Cevallos and seconded by Trustee Sparks to accept the Monthly Financial Reports as presented and to approve the disbursements shown on the August Monthly Disbursement Reports in the amounts of \$4,644.44 and \$16,405.26. Motion carried by roll call vote.
