

## WAIVER AND RELEASE OF LIABILITY

As a member of the Laguna Beach Lawn Bowling Club (hereinafter the "Club") or other clubs within the Southwest Division (including the SWWD and SWLBA organizations, hereinafter the "Division") and/or Bowls USA, I wish to participate in various activities offered or sponsored by the Club, the Division, or Bowls USA. These activities include, but are not limited to, the activity of lawn bowling in games, tournaments, league play, visitations and practice sessions as well as social activities of any kind using the clubhouse, greens or other facilities of the Club or the Division. I understand that I will be participating in activities requiring moderate effort including walking, stepping up and down on a grass or hard surface, and rolling a bowl weighing approximately 3.5 pounds as well as similar exertion activities. I am aware that risks of participating in these activities could include the risk of physical injury and or death caused by, but not limited to temperature, weather, use of equipment, infectious diseases, over-exertion, my own physical condition, and, actions of other people whether negligent or not, including, but not limited to other members of the Club, the Division, or Bowls USA.

In consideration of being permitted to participate in Club, Division or Bowls USA activities, I hereby take this action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows:

(A) I Waive, Release and Discharge from any and all liability for my death, disability, personal injury, property damage, property theft or actions of any kinds which may hereafter occur to me, the Club, the Division, Bowls USA, the City of Laguna Beach, and their officers and directors and members,

(B) I do, and agree to, Indemnify and Hold Harmless the aforesaid entities and individuals for myself, my heirs, executors, administrators, legal representatives, assignees and successors in interest from any and all claims including claims arising from the releasee's own negligence, and from any and all injuries and/or damages which may be sustained by me directly or indirectly in connection with, or arising out of my participation in or association with the Club, the Division, or Bowls USA activities, including without limitation travel to or return from Club events.

I acknowledge that this Waiver and Release of Liability when executed by me will be used by the Club, the Division, or Bowls USA for any and all activities in which I participate and further acknowledge that it will govern my actions and responsibilities. This Waiver and Release shall remain in full force and effect throughout my entire Club and Division membership.

This Waiver and Release of Liability shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.
