At any time during the course of this meeting, the City Commission may retire to executive session under Texas Government Code 551.071 to confer with its legal counsel on any subject matter on this agenda in which the duty of the attorney to the city commission under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with Chapter 551.071 of the Texas Government Code. Further at any time during the course of this meeting, the City Commission may retire to deliberate on any subject slated for discussion at this meeting, as may be permitted under one or more of the exceptions to the Texas Open Meetings Act set forth in Title 5, Subtitle A, Chapter 551.071, Subchapter D of the Texas Government Code.

SECTION 5. Consideration and possible action to adopt a Resolution authorizing the submission of an application to the Texas Water Development Board (TWDB) for financial assistance under the House Bill 500 Water Systems Infrastructure Grant (WSIG) Program in an amount not to exceed \$ 21,000,000, for the City's Water System Infrastructure Improvements Project, including water plant expansion, advanced metering infrastructure (AMI), water distribution system improvements, transmission mains, pressure management improvements, and related appurtenances; designating the Mayor as the Authorized Representative; and authorizing the preparation and submission of all required application documents.

SECTION 6. Consideration and possible action to authorize the City Mayor to execute and submit all resolutions, affidavits, certifications, application forms, and other documents required by the Texas Water Development Board (TWDB) in connection with the City's application for financial assistance under the Water Systems Infrastructure Grant (WSIG) Program authorized by House Bill 500, including any amendments, supplemental information, or additional documentation necessary to complete and administer the application.
