(LETTER FROM A LICENSED VETERINARIAN DETAILING THE ILLNESS/DEFECT IS REQUIRED)

- GUARANTEE TO BE FREE FROM ANY GENETIC DEFECTS THAT ARE DETRIMENTAL TO THE HEALTH OF THE PUPPY FOR 1 YEAR FROM DATE OF SALE - IN THE UNFORSEEN EVENT THAT A GENTIC DEFECT IS FOUND, SELLER WILL REPLACE PUPPY WITH ANOTHER PUPPY AS SOON AS ONE BECOMES AVAILABLE, ASSUMING WRITTEN LETTER FROM LICENSED VET WAS PROVIDED TO SELLER.
- IN THE CASE OF A SUDDEN DEMISE OF PUPPY, SELLER MUST RECEIVE WRITTEN NOTICE OF PUPPY'S DEATH FROM BUYER'S VET, ALONG WITH NECROPSY RESULTS STATING CAUSE OF DEATH (CAUSE MUST BE DETERMINED TO BE DUE TO CONGENITAL DEFECT ONLY) BUYER WOULD THEN GET 1ST PICK (BEHIND THE BREEDER & PRIOR DEPOSITS ALREADY PLACED) FOR A REPLACEMENT PUP OF SAME SEX & OF EQUAL VALUE.
- SELLER IS NOT RESPONSIBLE FOR ANY VET BILLS & WILL NOT REIMBURSE!! AFTER PUPPY IS IN YOUR CARE, REFUNDS WILL NOT BE GIVEN FOR COMMON THINGS SUCH AS: FLEAS, TICKS, WORMS, COCCIDIA, KENNEL COUGH, GIRARDIA, ETC DUE TO THERE BEING NO WAY TO PROVE WHOSE CARE PUP WAS IN WHEN CONTRACTED.
