SASB (Sustainability Accounting Standards): Integrating sector-specific ESG disclosures.

- *Enhancement:* Explore the evolving sector-specific metrics and disclosures under SASB, providing insights into how organizations can adapt to changes.

AA1000 Assurance Standard: Understanding the principles of ESG assurance.
