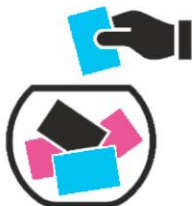

#### Set Up and Brake Down

- All Vendors must be **Set Up** between 7:00 am – 8:00 am the day of the event.
- Each Vendor must be continually staffed between 8:00 am and 5:00 pm
- Vendor **Brake Down** begins at 5:00 pm and all Vendors **must be fully cleared** from the area by 6:00 pm

#### General Provisions

- There is no rain date and no refunds will be issued due to inclement weather or other acts of nature. The Praise Out Cancer Foundation reserves the right in their sole discretion to cancel the event in whole or part due to inclement weather and no refund will be issued.
- Each Vendor will keep their designated area clean and free of debris during the entire day. A final cleanup must be done at the end of the event.
- Vendors are to provide a trash container for disposal and the vendor is responsible for removing any garbage from their area.
- Vendors are responsible for providing their own tents, tables, chairs, LP gas, etc.
- All Vendors that use flammable gas will have a fire extinguisher that meets state and local fire codes.

## Insurance and Liability

- All Vendors are responsible for their own liability insurance.
- Vendor understands that they are not covered by any insurance policies on behalf of the Praise Out Cancer Foundation, or any entity affiliated with the POC Walkathon and will submit a copy of his business insurance policy covering this event.

## Tax and Health

- Sales tax and licenses are the responsibility of each vendor. Information regarding taxes may be obtained from the SC Department of Revenue by calling 1-844-898-8542. Vendors must display a current SC Business License or proof of exemption.
- Vendors are required to charge the County of Orangeburg 2% Hospitality Tax on all prepared or modified foods and beverages. Taxes must be remitted monthly to the City of Orangeburg Finance Department or online at [www.orangeburg.sc.us/pay-apply](http://www.orangeburg.sc.us/pay-apply).
- Each remittance must be accompanied by a completed Hospitality Tax Reporting Form. Remittance forms are available online to <https://www.orangeburg.sc.us/hospitality-tax>.
- All vendors must comply with SC Department of Health and Environmental Control Food Safety guidelines, available at <https://scdhec.gov/food-safety/retail-food>.

## Agreement and General Release

- Vendors are independent agents.
