A Perpetual Care Cemetery

General Rules and Regulations:

1. Speed Limit within the Park shall be no more than 10 miles per hour.
2. No dogs permitted on Park grounds.
3. Cut flowers permitted any time. Artificial decorations permitted in attached vases only. Potted plants and baskets permitted only on Easter, Mother's Day, Father's Day, and Memorial Day. Digging holes is strictly prohibited. No glass containers at any time.
4. Fresh and artificial floral arrangements, and other decorations suffering in appearance will be removed from grave by cemetery personnel, if not removed by the family. Christmas decorations will be removed by cemetery personnel, if not removed by the family by March 1st.
5. Open entry to the Park is maintained, allowing access to loved ones at all times; therefore, the Park is not responsible for damage done by thieves, vandalism, riots, war and Acts of God.
6. The Park reserves the right to correct any errors that may be made in the Park operations, and to perform the care and maintenance of the grounds.
7. No person other than the proper employees of the Park shall be allowed to perform any work within the Park without a written permit from the officers or managers of the Park.
8. The Park reserves the right to cross over lots where interment rights have been sold in order to carry on its normal operation.
9. Interment rights may be purchased in the Park only with the written approval of the officers or manager, and subject to the rules and regulations of said Cemetery now and hereafter adopted, and for the purpose of interment only. This provision applies to all sales, whether made directly by the park or sales made by Owners.
10. The Park may exchange burial space when desired by Owners to other burial spaces of equal value where available.
11. Benches, chairs, crosses, edging and all other items which may impede perpetual care are strictly prohibited, unless approved in advance by Park management.
12. Planting of permanent trees, shrubs, or placement of any permanent structure is not allowed without the express written consent of park management.

Funeral Regulations

1. No burial shall be made until the purchaser shall have paid the entire price of the interment space, and the interment cost.
2. No one shall be buried in any lot not having an interest therein, except by written consent of all parties interested in such lot and of the Park.
3. Notice of 24 working hours before the announced time of the funeral will be required except at the discretion of the management of the Park.

4. There will be an extra charge for Saturday funerals, and no Sunday or Holiday funerals unless approved by the management.
5. All traditional (casket) burials will be placed in an Outer Burial Container – either a grave liner, or traditional burial vault.
6. All cremated remains must be in a sealed, impermeable, non-crushable urn – or urn vault.
7. Cremated remains may not be spread on, or at any gravesite.
8. Up to two (2) sets of human cremated remains may be buried in a single gravesite. They must be buried in a sealed permanent container.
9. Up to one (1) traditional set of human remains and one (1) set of human cremated remains may be placed in a single gravesite.
10. Two sets of casketed human remains may be buried in one gravesite – double depth – where applicable.
11. All funeral directors must give the Park the expected time of arrival, and keep the Park notified of any changes from than time.

Memorial Regulations

1. All memorials must be approved by the Park management.
2. Woodlawn Memorial Park reserves the right to remove any monument that does not conform to park standards or is installed outside of the normal approval and installation process.
3. The marking of each grave site is restricted to flat bronze memorials placed on granite set flush with the turf, unless otherwise specified by the designated section (Wildflower Garden, Estate Garden)
 - a. Wildflower Garden: All sites will be marked with a standard engraved river rock provided by Woodlawn Memorial Park.
 - b. Estate Garden: Sites will be marked using upright granite monuments.
 - i. All monuments will be no more than 2 feet in depth.
4. All monuments will be no less than 2 feet wide, and no wider than the boundary of the purchased grave space(s). No more than two (2) markers may be placed on each gravesite.
 - a. The second marker on any grave space, regardless of section, must be flush to ground.
5. A deposit of at least 50% of the cost of the memorial will be required before ordering the memorial, and no memorial will be installed until it is paid in full.
6. All memorials shall be installed by the cemetery's employees, or a licensed and insured monument company. Proof of licensure and insurance must be provided in advance of installation.

7. Woodlawn Memorial Park requires 48 hours prior notice of any monument installation, and all installations must be completed during normal business hours.
 - a. Woodlawn Memorial Park reserves the right to deny or reschedule monument installation if it is deemed that it will interfere with scheduled services taking place on the property.
8. All memorial foundations will be poured by Woodlawn Memorial Park staff or their designates. Foundations and are required to be the same size are memorial base.
9. All memorial fees must be paid prior to installation.
 - a. This includes: Admin Fee, Staking/Marking Fee, Installation Fee and Endowment Guarantee, Foundation costs, etc.
 - b. Upright monuments may not be delivered to Woodlawn directly and must be installed by the licensed monument company they were purchased through.
