Guest Agreement

Payments

Your reservation is secured by the 50% payment of the total rental rate plus the 16% Mexican tax. The balance is due 15 days prior to arrival. Please be advised that payments are non-refundable

Cancelation policy

Cancelations must be informed 20 days prior to your visit. Please be advised that payments are non refundable unless we can rebook the property at the full rental rate. In that event we will give a reimbursement equivalent to 85% of your payments.

Age Requirement

A responsible adult must accompany any guest under 18 years of age. Adults traveling with children and minors are solely responsible for them. There is no lifeguard on duty at the pool.

Rental Contract Violations

We reserve the right to reject or immediately terminate the rental without refund if in our opinion the Guest has violated rental policies and/or is detrimental to the property. The number of guests in the property is restricted to the original reservation. Guests may be charged for any additional people staying in the property without advance notice.

Losses and Damages

Guests are responsible for all damage and loss to the property during their stay and are required to secure the property by keeping it locked at all times. Guest agrees to surrender the property in the same condition as at commencement of the rental period and be responsible for excessive cleaning, repair and housekeeping expenses caused by the Guest. An inventory and inspection will occur after every rental and Guest agrees to be charged after the rental for additional repairs and charges, accidental

damage or breakage in excess of \$10, missing items (towels, sheets, controllers, DVDs, Decor. etc), or damages to the property or the common areas. Property Owner shall not be responsible for missing or stolen property of any Guest, and Guests are asked to use the property safe to store money, tickets, travel documentation, jewelry and other valuables at all times.

Maximum Occupancy

Maximum occupancy is 6 people (including any children). Exceeding the maximum occupancy at any time is not permitted without expressed written approval due to property owner requirements, health regulations, building codes, and other. Parties, weddings, functions of any sort, involving added guests, necessitate explicit Owner's permission and otherwise are not permitted.

Check-in time is 3:00pm local time, check out 11:00 am local time. Local time is CST (Day light savings time does vary from the U.S.)

No pets are allowed.

No smoking is allowed inside the property.

Rules and regulations for the common use areas have to be strictly followed.

Construction
