THE ORGANIZATION RESCUES PUPPIES AND ADULT DOGS THAT WERE SCHEDULED TO BE EUTHANIZED BY OTHER ANIMAL SHELTERS. AFTER BEING RESCUED, THE ORGANIZATION PROVIDES THE ANIMALS WITH ANY NECESSARY MEDICAL TREATMENT, INCLUDING VACCINES, WORMING, SPAYING/NEUTERING, FOOD, AND TEMPORARY HOUSING BEFORE THEY ARE DETERMINED TO BE OLD ENOUGH AND HEALTHY ENOUGH FOR ADOPTION. THE ORGANIZATION THEN POSTS PICTURES ON SOCIAL MEDIA OF THE RESCUED ANIMALS READY FOR ADOPTION AND TRANSPORTS THEM TO ADVERTISED ADOPTION EVENTS OPEN TO THE PUBLIC. THE ADOPTING FAMILY OF A RESCUED PUPPY OR DOG PROVIDES AN ADOPTION DONATION TO THE ORGANIZATION AND IS PROVIDED A WEEK HEALTH GUARANTEE SO THAT ANY ILLNESS, ISSUE, OR MEDICAL TREATMENT AN ADOPTED PET NEEDS IS 100% COVERED BY THE ORGANIZATION. ADDITIONALLY, THE ADOPTED FAMILY IS PROVIDED A FREE VETERINARY EXAM AND FECAL TESTING TO BE USED WITHIN ONE WEEK AFTER THE ADOPTION. IN SUMMARY, THE ORGANIZATION RESCUES PUPPIES AND ADULT DOGS THAT WERE PREVIOUSLY SCHEDULED TO BE EUTHANIZED, PROVIDES NECESSARY MEDICAL TREATMENT, FOOD, AND TEMPORARY HOUSING, AND THEN PLACES THEM IN ADOPTIVE FAMILIES.
