# Updates: Saline County

#### **Bryant Bombshell:**

In a special-called meeting held on Monday, September 18th, the Bryant City Council voted unanimously in a call to request that Mayor Allen Scott resign from his office. The Council also unanimously voted affirmatively in a "no confidence" vote against him, and stripped him of all resources/powers not uniquely granted to the office of Mayor by the Arkansas Constitution. Though there is an ongoing lawsuit against the Mayor in his official capacity by a former Bryant PD police officer, the request that he resign came as a result of an EEOC filing made in August.



This claim alleges that a city employee had been terminated as retaliation for reporting sexual harassment in the workplace by both the Mayor and other supervisors. According to records returned to MySaline by the city's HR department, it appears that Mayor Scott *did* admit to a sexual relationship with the woman, but insists that it was consensual.

#### **Walters Walks:**

Continuing the trend of surprise resignations this month, Justice of the Peace JR Walters (District 12) announced in September that he will be resigning from his position as Justice of the Peace, as he is relocating out of his current district. It appears that his final meeting as JP will be October's Quorum Court meeting, after which his seat will be filled via appointment until the 2024 election.



# Updates: Saline County

#### **UALR Registration Drive:**

The Young Democrats of UALR held a voter registration drive on September 19th, successfully **registering 50+ people to vote** in a single day! This incredible feat was, in part, made possible by our very own *Suzy Velez*, who took time out of her busy schedule to help train these Young Democrats on how to register folks to vote. Suzy is an incredible example of how the good work we do here in Saline County can make a difference not only locally, but statewide as well.



# Updates: Arkansas

#### **UAPB Underfunded:**

In a letter to Governor Sanders, the United States
Department of Education claimed that the state of
Arkansas has systemically underfunded the University of
Arkansas at Pine Bluff, alleging a funding disparity of
\$330.9 million over the last 30 years. In the letter, the
Secretary of Education, Miguel Cardona, pointed out that
this funding disparity creates an inequitable distribution of
resources and investments granted to historically Black
colleges and universities. The letter asks that the funding
given to UAPB be increased to rectify this issue.



Naturally, in response to the reasonable and fact-based claims made by the Dept. of Education, Sanders' comms director, Alexa Henning, responded by calling the letter "threatening [and] politically charged." Notably, 16 other states also received similar letters from the Dept. of Ed, but of course Henning and Sanders would take it so personally.

#### **Zom-Bob Ballinger:**

Like a zombie or an annoying film franchise, Bob Ballinger doesn't seem to understand that we don't WANT him to come back. The Crawford County Library Board, currently facing legal action as a result of unconstitutionally relocating books in the library based on discriminatory viewpoints against the LGBTQ+ community, has hired former Republican Senator Bob Ballinger as their legal counsel. If it wasn't clear that Crawford County's leadership was more than happy to make a political statement out of their library before, their employment of a deeply divisive former elected official as their legal counsel seemingly reinforces their position on the matter.




#### It's Best to Test:

#### Rupert's Resignation:

Rupert Murdoch has stepped down as the head of Fox News after what seems like far too many lifetimes at the helm. Of course, this is unlikely to greatly improve the "quality" of what Fox News produces, as Lachlan Murdoch, Rupert's 52 year old son, has assumed sole control of Fox and News Corp.



#### Canada/India Strife:

The diplomatic ties between Canada and India are being tested this year, as Canadian PM Justin Trudeau publicly stated last week that Canada has discovered evidence potentially linking Indian officials to the June assassination of a Sikh Canadian leader, Hardeep Singh Nijjar. In response, India denied the allegation and expelled a Canadian diplomat. This is a remarkable escalation, as Canada currently has the greatest Sikh population of any nation outside India, with 2.1% of the Canadian population being Sikh.

As of writing, it awaits to be seen what the U.S. response will be, as the Biden administration has been working hard to form stronger ties with the Indian government to counter Chinese influence.
