Minutes

Call to Order

Bailey Morgan, Chair called the meeting to order at 6:30 p.m.

Pledge of Allegiance

Approval of Minutes & Financial Statement

- 1. Minutes from 10/8/24 and 11/12/24 were approved
- 2. The financial report was not available as Tamme Adams was not present. Bailey gave an update that our bank balance was \$8,396.84 and we have not had any out of the ordinary expenses.

Discussion/Informative Items

Martha West mentioned that we need to pay our annual fee to the City of Benton for the Farmer's Market/Christmas Parade/Mistletoe Market.

Melinda Hensley reminded everyone that we need to form a committee and start planning the Kickin Blue. Please reach out if you are interested in serving on the Kickin Blue Committee. Kickin Blue is our annual fundraising dinner. Melinda Hensley asked if anyone was interested in attending the Bryant Chamber of Commerce Annual Banquet on January 7th. Tickets are \$75 each. Please pay your \$75 to Melinda Hensley if you would like to attend and she will reserve a table.

Melinda Hensley recommended that our committee look at getting a liability insurance policy. Currently we are not insured if someone falls or gets hurt and decides to sue us.

Bailey Morgan updated the membership on the recent termination of the Saline County Republican Party. This is a two year termination for them.

Lela Chism stated that the Women's Group will not meet in December but will resume in January. Lela gave an update on the abortion amendment stating that it will not resume activities until after this legislative session.

Martha West discussed her goal of having a safe place for LGBTQ kids to come hang out at the office. Melinda Hensley asked what type of liability we would have from parents of children under the age of 18. Do we run the risk of a parent suing us for "influencing" their child? She stated she is comfortable with reaching out to young adults over the age of 18 but had concern about parents of younger children.

Olivia Bauer, member of Young Democrats at Bryant High School, suggested we have meetings for Young Democrats and don't specifically target LGBTQ kids. Danny Brown expressed a similar opinion.

Bailey Morgan stated he is comfortable with the idea as long as two adults were present and one of them being an officer of the party. He stated he will try to be available for a once per month meeting. Several in attendance volunteered to come to the meetings and there was widespread support for the idea from members.

Felix Stacy thanked Martha and team for the Christmas window decorations.

Felix Stacy made a motion to adjourn the meeting and Terese Brown seconded the motion.

The meeting was adjourned at 7:10 p.m. and everyone enjoyed a potluck meal after the meeting.

ARTICLE III: DPSC Officers

Section 1

The elected officers of the DPSC are: Chair, 1st Vice-Chair, 2nd Vice-Chair, Secretary, and Treasurer. In accordance with DPA rules, The Chair and 1st Vice-Chair shall be of differing gender identities.

Section 2

- A. Officers shall be elected by the newly constituted County Committee for two year terms starting in January of odd-numbered years, immediately after the General Election.
- B. The DPSC shall strive to reflect the diversity of Saline County in the election of its officers.
- C. No person can occupy more than one elected office.
- D. Within ten days after the organization of the new DPSC, the Secretary shall forward to the Secretary of the DPA a list of the names, addresses, and other contact information of the newly elected officers.

Section 3

A. Chair

a. The Chair shall call and preside at all meetings of the DPSC; oversee the day-to-day affairs of the DPSC; serve as chairperson and voting member of the Executive Committee; serve as ex officio member on all committees; call meetings of the Executive Committee and District Representatives, when necessary; serve as spokesperson for the DPSC; and make appointments to committees of the DPSC.

B. 1st Vice Chair

a. The 1st Vice-Chair shall preside at DPSC meetings in the absence of the Chair, shall coordinate programs at DPSC meetings that promote the purposes of the DPSC, and carry out such other duties as delegated by the Chair.

C. 2nd Vice Chair

a. The 2nd Vice-Chair shall maintain accurate membership rolls of the DPSC; serve as interim secretary in the absence of the Secretary; and carry out such other duties as delegated by the Chair. The 2nd Vice-Chair will also actively recruit members and help keep members involved.

D. Secretary

a. The Secretary shall record all minutes and votes of DPSC regular meetings and Executive Committee meetings, and prepare them for consideration by the body at the subsequent meeting; shall preserve all important records and papers of the DPSC; and carry out such other duties as delegated by the Chair.

E. Treasurer

a. The Treasurer shall maintain the financial records of the DPSC and provide written reports at regular meetings and with the Chair, shall be a co-signature authority on any bank accounts and withdrawals. All records of the Treasurer shall be subject to audit at the request of the Chair or Executive Committee.

Section 4

The elected officers shall constitute the standing Executive Committee. The Executive Committee shall carry out the business of the DPSC as designated by the DPSC and make decisions within its powers in the interim when the DPSC does not meet. It shall also serve as the budget committee for the organization and shall present to the DPSC regular financial reports and expenditures for approval.
