Call to Order

Bailey Morgan, Chair called meeting to order at 6:32 p.m.

Pledge of Allegiance

Approval of Minutes & Financial Statement

- 2. Financial statement presented by Chair

Announcements

- 1. Bailey announced Kickin' Blue was a major success, breaking past fundraising and attendance records
- 2. Steve Rittenmeyer introduced Nancy Baumgartner, HSV Democratic Club President



- Bailey shared the Committee's plans to alter our attendance at Farmers' Markets and Third Thursdays going forward.
- 4. Bailey announced a canvassing event to be held on May 25, 2024 across the entire county.

Action Items

- Bailey presented a plan for a second round of candidate donations as approved by the Executive Committee, being a repeat of the donations made to candidates in December, 2023 (\$500 to House Districts 81, 82, and 83; \$350 to each opposed JP District).
 - a. First Vice Chair Laura Butler expressed the view that Saline County money should stay in Saline County
 - b. Martha West motioned to donate \$500 to Marcus Jones in addition to the plan agreed upon by the Executive Committee.
 - i. Seconded by 'Nita Brown and passed unanimously

Discussion/Informative Items

- Bailey discussed the DPA's new Block Captain program. This program assigns a volunteer 50 residents in their neighborhood for that volunteer to form relationships with and convince to vote for Democrats by November.
- Bailey and Secretary Melinda Hensley have agreed to swap their previously Chaired committees, with Bailey assuming the Chair position of the Voter Outreach Committee and Melinda assuming the Chair position of the Fundraising Committee.
 - a. Bailey made a request for members to consider signing up for the fundraising committee.
- 3. Bailey announced a candidate event hosted by the DPSC at Silver Springs on Saturday, September 21st, 2024 @ 6:30 P.M.



- 4. Second Vice Chair Felix Stacy encouraged members meet and converse with their JPs. He also stated that, due to complications at recent Farmers' Markets, the DPSC will no longer have petitions on-site when volunteering, and will instead hold them at HQ for anybody interested in signing.
- 5. The next meeting will be June 11th, 2024 at 6:30 P.M.
