May 16, 2019, International Directors Meeting Notes

IRWA Board of Directors Meeting Notes

On May 16, 2019, in preparation for the annual IRWA Board of Directors (BOD) Meeting, IRWA held a video conference 9 AM with the International Governing Council (IGC) and International Leadership to discuss items to be voted, which included:

- the election of the International Executive Committee Officers;
- a proposed amendment of International bylaws to allow for corporate membership discounts; and
- the proposed 2019-20 budget.

The bylaws resolution is to create a corporate membership, individual voting, and language cleanups. This will allow corporate memberships, similar to government memberships, to

incentivize corporate participation. In addition, when a corporate employee leaves, the corporation owns membership can transfer it to a different corporate employee.

Regarding the corporate membership proposal, I inquired if the IEC had determined the financial impact of the proposed bylaw revision, since membership income makes up 40% of the IRWA's income, and corporate employees make up the majority of the Chapter 4 membership. The response was no analysis had been done determination of how finances would be affected. I expressed concern that we should not be revising bylaws without first knowing the full impact.

In addition, to these items we received the following updates:

- Since the CEO was terminated without notice, he was paid 6 months' salary, benefits, and an additional year's salary.
- A search for a new CEO will take time.
- The cost of the HR investigation is small, still being accrued and will be relayed later.
- The investigation is not public and will not be shared.
- Deidra Alves is on a leave of absence and the PIPE Committee took over World CLIMB.
- The CFO has retired and Rahkshan is filling this position on an interim basis.

Annual Conference Recap

Chapter 3 did an amazing job hosting the annual conference in Portland, in which Jim Lingeman and Leslie Finnigan served as co-hosts. There were 1,267 individuals in attendance, making it the third largest conference in the history of the IRWA. I took several pictures, which will be uploaded, to our Chapter website soon.
