#### **International Awards**

It was a pleasant surprise when Jade Meador, IRWA Director of Events, recently notified me that our Chapter is a finalist for the award category *Gene L. Land - Highest Numerical Gain for Membership*. This is the second year in a row, we have been a finalist, and last year we won this award for growth in 2017, with 21 new members!

As you may recall in my January message, I predicted our current growth rate could garner another award. This year's award is based on gain for the calendar year 2018, which saw a significant increase of 91 new members joining Chapter 4. Forty-seven (47) joined during our current fiscal year beginning July 1, 2018, and the remaining 44 during the previous fiscal year.

The other two Gene L. Land award finalists for highest numerical gain in membership are Chapter 63, Region 8, Ottawa, ON, and Chapter 83, South Africa. The winner will be announced at the Awards Luncheon at the IRWA Conference on June 10 in Portland, OR. This makes the fifth award, which our Chapter and/or its members have been nominated. The other four categories are:

- 3. Miller Nash Graham & Dunn LLP for Employer of the Year (less than 20 employees)
