I. COMPETITION OVERVIEW

Mayblades will be conducted in accordance with the rules and regulations of U.S. Figure Skating, as set forth in the [current rulebook](#), and/or [current Compete USA handbook](#) as well as any pertinent updates that have been posted on the U.S. Figure Skating [website](#).

This competition is open to all eligible, restricted, reinstated or readmitted persons as defined by the Eligibility Rules.

Skaters must be a currently registered member of a U.S. Figure Skating member club, Learn to Skate USA® member, a collegiate club or who is an individual member in accordance with the current rulebook. For non-U.S. citizens, please refer to the [rulebook](#) for more information.

SERIES INFORMATION: We're excited to announce that Mayblades is offering both the 2025 Excel series and the 2025 PNW Basic Skills Series.

2025 Excel Series: This competition has been approved as a 2025 Excel Series host. Skaters must register to participate in the Excel Series prior to competition at designated competitions in order to have their points recorded and seen in standings. 2024-2025 Pacific NW Basic Skills Series and Championship: If you have not signed up for the series, you will need to do so before your first competition by going to either the PNIC or OSC websites listed below. **Skaters must compete in a minimum of 3 competitions throughout the series before the final deadline August 17, 2025.** Once you are signed up with PNW Basic Skill Series, your scores will automatically be sent to PNIC/OSC for recording. II. ELIGIBILITY

Singles: Excel and Well-Balanced Events:

- Skaters must meet at least the minimum singles test requirements for the event's level. A skater's singles test level may be higher than the minimum requirement.
- Skaters may not register for an event level lower than allowed by their competitive floor. An athlete's competitive floor is set by one of the following scenarios:
 - o If an athlete has a paid EMS series application for the NQS series, the event level registered for in the most recent NQS will become the lowest level they may compete at in any U.S. Figure Skating sanctioned event.
 - o If an athlete has a paid EMS series application for the Excel Series, the event level registered for in the most recent Excel series will become the lowest level they may compete in any Excel event. For Well-Balanced and Specialty events the skater will be permitted to register at one level lower than the "floor" set by their excel series entry.
 - o If an athlete has never had a paid EMS series application in the NQS or Excel series, the athlete may select their level based on their goals and technical skills as long as the minimum test requirements are met.
- Skaters are not permitted to enter an Excel free skate and a Well-Balanced free skate event at the same competition (example: Juvenile Girls Free Skate and Juvenile Girls Excel Free Skate). However, they are permitted to enter an Excel and a Well-Balanced event of different types such as a short program (if stand-alone event option), specialty or showcase events (example: Intermediate Women Short Program and Intermediate Women Excel Free Skate).

All other singles and partner events:

- Skaters must meet the minimum test requirements for the events level, but not exceed the maximum permissible test requirement.

COACHES

To be an eligible coach at a nonqualifying competition, coaches must meet the applicable compliance requirements and verified by U.S. Figure Skating. Coach compliance falls into two categories, Coach Compliance (includes choreographers) and Learn to Skate USA® Instructor Compliance. Details regarding compliance requirements can be found [HERE](#). All compliance requirements must be met at the time of check-in to access the competition, no exceptions.

Coaches of foreign athletes: If you are a coach of a foreign athlete only, you are not subject to U.S. Figure Skating coach compliance and will only be asked to provide a letter of good standing for the federation your athlete represents.

With EMS, coaches must be included within a skater/team's registration or updated through their EMS Skater Portal via "[My Coaches](#)" or "Team Personnel." All coaches declared at the time of registration will be included in the registration confirmation email. Note: There is no registration approval process within EMS as the data (membership and test level) is tied to the U.S. Figure Skating database. Non-compliant coaches will receive automated email reminders through the start of the competition.

MANDATORY ATHLETES

Athletes age 18+ as of the competition start date who will be competing on a team (i.e., synchro, ice dance, pairs, shadow dance, theatre, etc.) with at least one Minor Athlete must complete SafeSport™ Training. *

Minor athletes who turn 18 mid-season are encouraged to seek parental consent to take the online SafeSport™ Training early to avoid any disruptions in their ability to participate as the training is required upon turning 18. The athlete will not be compliant until they have completed the training and their Members Only portal reflects completion. FOREIGN SKATERS:

TEST CREDIT: You should use form at registration desk 1 hour before your event at this competition.

Singles Free Skate*: Juvenile**, Intermediate, Novice, Junior, Senior, and Adult Silver through Adult Senior Pairs Free Skate: Juvenile, Intermediate, Novice, Junior and Senior Free Dance: Juvenile, Intermediate, Novice, Junior and Senior

*Both Excel and well-balanced free skate IJS protocols are eligible for test credit.

**If an open juvenile free skate event is conducted under the IJS, the scores may be used for test credit for IJS Protocol for a juvenile free skate test, assuming all score requirements are met.

MUSIC SUBMISSION/UPLOAD:

EMS MUSIC UPLOAD: Competitors participating in events with music are required to upload their music to EMS no later than **May 1, 2025 at 9:00pm ET**. After this date, skaters will be locked out of this feature and subject to a **\$50 late fee**. The late fee will automatically be added to each skater's cart who doesn't meet this requirement

by the deadline. Late fees will not be removed under any circumstances and must be paid prior to receiving the skater credential onsite. If music is not submitted by the late deadline of 5/4/25, a fee of \$100 will be added.

DEADLINE: 5/1/2025 \$50 late fee, after 5/4/25 \$100 late fee

Competitors must also have available a backup copy of their competition music on a cell phone and it must be immediately available rinkside whenever the skater competes. If the phone does not have the standard round headset connector, an appropriate adapter, such as an Apple Lightning connector or Samsung USB-C adapter is required to be attached. The phone should be presented to the music person with the file ready to play, phone in airplane mode and volume turned to maximum.

The late fee will automatically be added to each skater's cart who doesn't meet this requirement by the deadline. Late fees will not be removed under any circumstances and must be paid prior to receiving the skater credential onsite. IV. COMPETITION DETAILS

FACILITIES:

The competition will be held at Sprinker Recreation Center, Located at 521 Military Rd. S, Tacoma Washington 98444. You may contact the arena by calling 253-798-4000. The ice dimensions of the rink are 85'X200'. There are vending machines available for small snacks and a large viewing area located upstairs, with access to an elevator.

LOCKER ROOMS AND CHANGING AREAS:

There are NO dressing rooms available for skaters to use, please come prepared and ready to compete. Athletes will be provided with an area to put skates on but changing will not be permitted in these spaces.

U.S. Figure Skating Travel Policy:

All travel must strictly adhere to Two-Deep Leadership requirements. An Adult Participant cannot transport a Minor Athlete one-on-one and Two-Deep Leadership requirements must be adhered to at all times during In-Program travel, by transporting at least two minors or a second Adult Participant. An Adult Participant cannot share a hotel room or other sleeping arrangement with a Minor Athlete(s). OFFICIAL WEBSITE & UPDATES:

Official notices will be emailed to competitors through EMS and posted to the LWC website, [Lakewood Winter Club](#). It is the responsibility of each competitor, parent and coach to read the messages for any schedule changes and/or additional information. Skaters are expected to arrive 45 minutes prior to the scheduled time of their event. A tentative schedule of the events will be posted prior to the competition. It is the responsibility of each competitor, parent and coach to check the schedule online frequently for any schedule changes and/or additional information pertaining to the competition.

SCHEDULE

Competitors may be scheduled on any day or time during the announced dates of the competition. The competition and practice ice schedule will be available after the close of entries. All participants will be notified via email once available.

PRACTICE ICE:

Practice ice is NOT included with your registration. Practice ice sessions will be 20 minutes. A maximum of 2 practice ice sessions may be requested per skater. Compete USA (Basic Skills) practice ice is 20 minutes and **no** music will be played.

Pre-Purchase: Practice ice credits may be purchased after participants complete their event registration, via the EMS Competition Portal. Skaters who purchase credits during the pre-purchase period will be able to select sessions during the selection period, after the schedule has been completed and posted.

ONSITE CHECK-IN:

Check-in will open two hours prior to the start of the competition schedule of that day and will be located on the second floor of the Sprinker Recreation Center.

AWARDS: Awards will be presented for first through sixth place in the Rainier Room upstairs immediately following the official posting of each event.

The Al & Iria Beeler Artistic Award – Al and Iria were the driving force that kept the Lakewood Winter Club and the Lakewood Ice Arena together from 1960-1982. They started going to the ice arena in 1953 when their daughter, Marianne, started skating. Iria started working at the rink as a bookkeeper in 1954 and became the manager in 1968, a job she held until the rink closed in 1982. Al became very active in the club and was president for eight years. He also held other offices such as treasurer and test chairman, and he served on the Board of Directors for more than 25 years. He became interested in judging and earned his Gold judge credentials. He was also very involved in the annual ice shows and spent countless hours building props. He worked tirelessly when the LWC hosted the 1987 U.S. Figure Skating Championships in Tacoma. When the Lakewood Ice Arena collapsed in 1982, Al worked hard to forge a relationship with Pierce County Parks & Recreation Department, allowing the LWC to transfer its operation to Sprinker Recreation Center. In their honor, the Lakewood Winter Club will present this award to a skater from the Intermediate through Senior Level, who the artistic judges feel presented the most artistic Free Skate performance.

VOLUNTEER COMPLIANCE:

Reminder: Compliant positions at all U.S. Figure Skating events include LOC leadership, locker room monitors and emergency medical providers.

For safety reasons, **no flash photography is allowed during the event.** Note, per U.S. Figure Skating policy, photographing and/or recording of anyone other than your own skater is strictly prohibited.
