## RULES/REGULATIONS

This page is for the teams to keep!

- All team members will be checked in prior to the start of the game (check in begins at 3:45pm)
- Teams consisted of 6 to 8 players.
- 1 Timeout granted (20 seconds) per team.
- Winning the game: A team must eliminate all members of opposing team. The tournament will be played with double elimination.
- 8 balls are allowed in regulation.
- You can not hold a ball for more than 15 seconds at a time.
- No throwing balls above the shoulders: 1st offense = WARNING, 2nd offense = DISQUALIFICATION.
- A team cannot hold all the balls on one side for more than 15 seconds.
- If ball bounces and hits opponent, opponent is safe.
- If ball is caught by opponent before ball hit's the ground, thrower is OUT.
- If ball hits and stays in air and is caught by teammate, the player is SAFE.
- If a ball hits 2 opponents before bouncing on the ground, both opponents are OUT.
- No stepping over mid-court line.
- Players must stay in boundary lines.
- Players must have team name. Must be appropriate.
- Teams are encouraged to wear matching uniforms colors, head/wristbands, clothing, etc.)
