This is a breeding agreement between the above-named Stud's Owner and the above Bitch's Owner.

For Fresh/Chilled or Frozen semen breeding's. the stud fee shall be \$ \_\_\_\_\_, the payable remaining balance due upon the whelping of the Bitch. Fifty percent (50%) of stated Stud fee shall be received by Stud's Owner plus expenses stated below before shipment or breeding.

The contract is valid for Stud Service selected and initialed by Bitch's Owner:

We base our Stud Fee off the sale of one puppy: We charge \$2500.00 plus collection and shipping costs:

Fresh/chilled semen is sent out the same day for next day arrival. Frozen semen must be shipped in advance to your Vet, it can be shipped now and stored at your local freeze bank to be on hand at any point you will need it.

The Stud Fee is payment of the stud service only and is not to be construed as a guarantee of puppies surviving the whelping. One (1) or more live puppies constitutes a litter. In the event no litter is produced a repeat breeding at the Bitch's next heat will be provided with only collection and shipping costs at Bitch's Owner expense, if the Bitch's owner so chooses. A refund will be returned to the Bitch's Owner less the collection and shipping costs if the Bitch's owner decides against an additional breeding.

The Stud's Owner is not required to sign the AKC Litter Registration papers until such time as the Stud Fee and all reimbursable expenses due to the Stud's Owner are paid in full by the Bitch's Owner.

The Bitch's Owner will agree to:

A: The Bitch's Owner agrees to perform an adequate number of blood sample tests to measure serum concentrations progesterone and/ or luteinizing hormone (LH) to help assess the timing of the LH surge, first day of estrus and optimum days for breeding by artificial insemination (AI).

B: The Bitch's Owner certifies that the Bitch has not been bred to any other male during this heat cycle, and that utmost care will be taken to ensure that she is not bred to any other male after this service has been provided.

C: That the puppies will be given proper care.

#### Part 1: Artificial Insemination using Fresh/Chilled Semen (not shipped)

The Stud Fee is to be paid upon receipt of this contract, the AKC Form, health certificate of Bitch, application of using Fresh or Extended Fresh Semen filled in and signed by the Bitch's Owner. The Bitch's Owner is responsible for any charges for the collection and inseminations to be paid to the Stud's Owner licensed Veterinarian.

#### Part 2: Artificial Insemination using shipped Fresh/Chilled Semen (shipped)

The Stud Fee is to be paid upon receipt of this contract, the AKC Form, health certificate of Bitch, application of using Fresh or Extended Fresh Semen filled in and signed by the Bitch's Owner. Fifty percent (50%) of stated Stud fee shall be received by Stud's Owner plus expenses stated before shipment or breeding.

The Bitch's Owner is responsible for charges of the semen collection, semen preparation, shipping container and all other packing and handling fees incurred in the shipping of the specimen charged by the Veterinarian or storage facility. The Bitch's Owner is responsible for any charges for the inseminations.

#### Part 3: Artificial Insemination using (shipped) Frozen Semen

The Bitch's Owner is responsible for charges of the semen collection, semen preparation, shipping container and all other packing and handling fees incurred in the shipping of the specimen charged by the Veterinarian or storage facility. The Bitch's Owner is responsible for any charges for the inseminations.

Stud Fee: The stud Fee is \$ \_\_\_\_\_ plus the Veterinary charges for semen collection and preparation. Fifty percent (50%) of stated Stud fee shall be received by the Stud's Owner plus expenses stated before shipment or breeding.

Bitch's Owner shall pay the balance of the stud fee 10 days after puppies are born.

#### Code of Ethics

The Bitch's Owner is expected to abide by the AKC code of ethics for the ownership, breeding, and registration of purebred dogs;

Provide the best care for their pregnant Bitch and resulting litter;

Make every attempt to place puppies in appropriate, sound and secure homes and shall not release puppies to New Owners until they are at least eight (8) weeks of age.

No offspring of mating are to be offered for sale to or through any pet shop, grooming parlor, humane organization, or any other Kennel.
