• Balance: The remaining balance of \$ is due when the kitten reaches 5 weeks of age.
• Pickup/Delivery: Puppies will remain with breeder until they are at least 8 weeks of age to ensure proper development, socialization, and health.
• <b>Shipping/Transportation:</b> Available at the <b>buyer's expense</b> and must be arranged in coordination with the breeder.

3. Health and Care Provided by Breeder: The breeder agrees to:
• Provide all <b>age-appropriate vaccinations and deworming</b> by the time of delivery.
• Offer daily socialization and playtime to ensure proper development.
• Supply all <b>medical records</b> , including vaccinations and deworming history.
• Provide AKC registration or certification paperwork.
• Keep the buyer <b>informed with regular updates</b> (including photos and notes) on the puppies health and care until transfer.
4. Buyer's Responsibilities:
The buyers agree:

- Have the kitten examined by licensed veterinarian within 3 days of delivery or pickup.
- Provide lifelong appropriate nutrition, housing, affection, and medical care.
- Buyer agrees to provide veterinary **care for the life of the puppy.** This includes vaccinations, deworming, etc.
- Never surrender the puppy to a shelter or rescue organization under any circumstances.

## 5. Return Policy:

• Should the buyer be unable to care for the puppy, the breeder agrees to help find an acceptable new family or accept the puppy back. **No Refund** is guaranteed unless otherwise agreed upon in writing.

## 6. Miscellaneous:

• The buyers must register their new puppy with **AKC papers** using of \_\_\_\_\_\_ **Incredible Danes** in their name.

- This agreement is legally binding and enforceable upon signature by both parties.
- No modifications are valid unless made in writing and signed by both parties.
- Both parties confirmed they have **read**, **understood**, and **agreed** to the terms set forth herein.

## 7. Act of God / Missed Picked Clause:

In the event that the buyer is unable to pick up the puppy on the scheduled pickup date due to circumstances outside of their control (such as natural disasters, medical emergencies, or travel interruptions), the buyer must notify the breeder immediately and reschedule within 7 calendar days.

- If the buyer fails to reschedule and possession of the puppy within this 7-day grace period, the contract becomes null and void, and the refundable deposit will be forfeited, Plus a rehoming fee of \$500. The remaining balance will be refunded in 5 to 10 business days.
- Open communication between the buyer and breeder is expected and required to manage any unforeseen delays.
