- d) Navajo Word of the Day (DNI)

- e) Updates:
 - i) Micah: Class attended a Indigenous Foods Webinar at the end of November with Cynthia Wilson
 - (1) Students wanted to grow a garden at the school. There is principal approval; but materials and logistics have not been figured out
 - Reagan: Master Gardener Program: Creating local sustainability through local food sources; planting a volunteers is coming together to start a community garden in Bluff
 - (1) UNHS attempted to create a garden, but one person was doing it alone
 - (2) Students can take a course and will sign up for volunteer hours
 - (3) Meeting today to discuss with UNHS nutrition aspect where food can go through a distribution site.
 - (a) Presentation was recorded and can be shared with others that were not there
 - iii) Cllayton: Still doing online Navajo Language Class, in February will transition to the Navajo Government class. This one will end at the end of April.
 - (1) Westwater still does not have electricity; In April (?) the city will take electricity up to Westwater and NTUA will connect each home to the grid.
 - (a) Water will be next- city and Westwater will drill a communal well to mitigate high costs
