GUIDELINES & VOTING PROCEDURES

★ GENERAL BODY VOTING ★



#1 REGISTRATION REQUIREMENTS

All voters must be registered with the General Body for the **October 2025, March 2026, and June 2026** council sessions.

- Voters **WILL NOT** be permitted to register for the March 2026 Council Session during the June 2026 Council Session.



#2 MEMBERSHIP REQUIREMENTS

All voters must be members of the Council and possess a valid NDC Membership Card (Current Year: **2024–2026**).

- Voters **CANNOT** purchase a current membership card during the June 2026 Council Session.
- Voters **MUST** have become a member by the October 2025 Council Session.

★ AUXILIARY VOTING ★



#1 GENERAL BODY REGISTRATION

All voters must be registered with the General Body for the **October 2025, March 2026, and June 2026** council sessions.

- Voters **WILL NOT** be permitted to register for the March 2026 Council Session during the June 2026 Council Session.



#2 MEMBERSHIP REQUIREMENTS

All voters must be members of the Council and possess a valid NDC Membership Card (Current Year: **2024–2026**).

- Voters **CANNOT** purchase a current membership card during the June 2026 Council Session.
- Voters **MUST** have become a member by the October 2025 Council Session.



#3 AUXILIARY REGISTRATION REQUIREMENTS

All voters for any NDC Auxiliary (as listed in the NDC Minute Book) **MUST** be registered for both the **October 2025, March 2026, and June 2026** Sessions with their respective Auxiliary, based on the required Auxiliary registration fees and in accordance with the Auxiliary Bylaws.

- Voters **WILL NOT** be permitted to register for the March 2026 Council Session during the June 2026 Council Session.
