Instructions for completing application—

Persons Applying for Status as an Official supporter: Please fill out first page of application (name, address, phone, email address) plus \$40 cash, check or money order and mail to post office box. (\$300 for status as an lifetime supporter). You may scan application and email it and use cash app \$dftcta for your payment. You do not need to provide any documents of your lineage or ancestry.

PERSONS APPLYING FOR VOTING MEMBERSHIP IN THE DESCENDANTS OF FREEDMEN ASSOCIATION:

You must fill out application (name, address, phone, email address) and include \$40 cash, check, or money order (\$300 for lifetime members) and mail application and supporting documents to our post office box. You may scan application and supporting documents and email it and use cash app \$dftcta for your payment.

YOU MUST ESTABLISH TO THE MEMBERSHIP COMMITTEE THAT YOU DESCENDED FROM A PERSON WHO WAS LISTED AS A FREEDMEN OF THE 5 TRIBES ON THE DAWES ROLLS. DOCUMENTS WHICH CAN ESTABLISH THIS COULD BE: ONE OR MORE OF THE FOLLOWING:

- 1. Letter from your ancestral tribe or the Department of Interior establishing that you are a freedmen tribal member or descended from a freedmen tribal member of the 5 tribes
- 2. Copy of tribal membership card for the applicant which states that you are freedmen, includes a roll number for a freedmen or which was made during a time when freedmen were being processed for tribal membership for that specific tribe. Tribal voting card may also establish your descent from a Dawes enrolled freedmen.
- 3. Copy of cancelled check, or other document showing you received per capita payment or judgement fund payment as a freedmen member or descendant of freedmen of your tribe. Your name being on list of persons who received a per capita payment or judgment fund due to freedmen status.
- 4. Federal, state, or tribal court records which establish that you are descended from a Dawes enrolled freedmen (issue not necessarily due to membership dispute could be real estate, probate, or property taxation issue)
- 5. Other Federal state or tribal documents which establish that you are descended from a freedmen: Death and heirship documents, etc.
- 6. Statement/Affidavit of your descendancy from a freedmen from a family member who has already established to the member-ship committee that they are descended from a Dawes enrolled freedmen.
- 7. Obituary, etc establishing your lineage from a Dawes enrolled freedmen.

VOLID ANCESTOD'S EDEEDMEN DOLL NUMBED AND NAME

IF YOU DO NOT HAVE ANY OF THE ABOVE DOCUMENTS AND ARE APPLYING FOR MEMBERSHIP:

THE DAWES COMMISSION ROLLS, WHICH WILL BE USED FOR VERIFICATION WAS COMPILED DURING 1898-1914. ANYONE WHO DIED PRIOR TO 1899 OR WAS BORN AFTER MARCH 4, 1906 DOES NOT HAVE A ROLL NUMBER, HOWEVER IF YOU CAN PROVIDE THE CENSUS CARD THAT SHOWS THE ANCESTOR YOUR APPLICATION WILL BE CONSIDERED FOR VOTING RIGHTS MEMBERSHIP.
