#### **Tournament Reservation Fee and Total Balance:**

The minimum number of players is 72. Tournament Reservation Fee is calculated for 72 players divided by 2 times the daily rate according to the day of the tournament. Fees for players over the 72-player minimum will be settled on the day of the tournament. The Tournament Reservation Fee is due 60 days prior to the event. The full invoice must be paid 30 days prior to the Tournament. If the event is cancelled prior to 30 days of the tournament, a 25% administrative fee will be assessed. Cancellations after 30 days will be handled on a case-by-case basis and may be subject to additional cancellation fees.

#### **Golf Cart (Rentals)**

As part of the golf package for the tournament, Wakulla Sands Golf Club will provide 36 golf carts free of charge. Outside of the 36 golf carts provided, the event will be responsible for the cost of the golf carts needed. The additional cart fees will be charged at \$25.00 per cart plus tax.

#### **Dress Code**

Signing the tournament agreement acknowledges an understanding of the Wakulla Sands Golf Club dress code policy and ensures the players' compliance. Golfers who arrive in non-dress code appropriate attire will be asked to change or leave.

### **Personal Property**

Wakulla Sands Golf Club does not accept responsibility for any personal property or valuables, including but not limited to cell phones, golf clubs, shoes, bags, apparel, jewelry or money left in golf carts, vehicles and parking lot areas, or on the golf course. Such items are the responsibility of each guest.

## **Proper Conduct / Waiver and Indemnity**

By signing this agreement, the client is responsible for proper conduct for all participants, use and care of the golf course, equipment and golf carts. The client is also responsible for all injuries to people, damage to property, equipment and golf carts caused by tournament participants. The client agrees to indemnify, defend and hold Wakulla County and the Wakulla Sands Golf Club harmless from all damages and injuries caused by event participants. Wakulla County and Wakulla Sands Golf Club reserves the right to remove anyone from the property who engages in disruptive behavior. It is expressly agreed that all use of Wakulla Sands Golf Club shall be undertaken by the client and its participants and their own risk, and, neither Wakulla County nor the Wakulla Sands Golf Club nor any other their employees or agents are liable for any injuries or any damage to the client or any participants, or the property of any client or participant, or be subject to any claim, demand, injury or damages, whatsoever, including without limitation, those damages resulting from acts of active or passive negligence on the part of Wakulla County, Wakulla Sands Golf Club, or any of their employees or agents.

### **Alcohol Policy**

If the tournament organizers prefer to use an outside vendor to provide alcohol, the organizer must complete the Wakulla County Alcohol Permit Application prior to the event. The organizer must comply with all the terms and conditions of the Alcohol Permit.

### **Mobile Food Vending**

If the tournament organizers prefer to engage a mobile food vendor, the organizer must complete the Wakulla County Mobile Food Vending Application prior to the event. The organizer must comply with all of the terms and conditions of the Mobile Food Vending Policy.

#### **Weather Policy**

Regardless of current weather conditions or predictions, all participants must show up at the assigned time for the tournament. Only at the assignment time of the tournament will a decision be made to cancel the tournament. The ultimate decision is entirely up to the Wakulla Sands Golf Club staff.

## **Club Rental**

Club Rentals for tournament participants must be prearranged by either the event's coordinator or each individual event participant at least 48 hours in advance of the tournament date. When checking out a rental set, each renter is required to provide a credit card while the clubs are at play. The event or participants will be charged for any missing or damaged clubs.
