As part of efforts to stimulate interest in the study of this new landscape and promote theoretical contributions around labor rights and social security, the Global Coordination of Young Jurists of the International Society of Labor and Social Security Law calls on lawyers, students, researchers to submit their written work for evaluation and subsequent presentation at the First World Congress of the Young Jurists Section to be held at the School of Law of the National Autonomous University of Mexico on May 21<sup>st</sup> and 22<sup>nd</sup> 2020.

The Congress will have the presentation of the reports prepared by the Regional Subsections (America and Europe, and representations of Asia, Africa and Oceania). These reports will be presented by the representatives of each Continent with the aim of bringing to the attention the realities and problems of each region. The topics have been centralized in three plenary sessions that will cover the following topics: A) "Regulating the individual employment relationship in times of transformation of production processes", B) "Collective action in the face of changes in the forms of work" and C) "The challenges of Social Security: How to protect everyone all the time?"

At the same time, workshops focusing on the discussion of the three proposed central issues will be held. They will be spaces for exchange and debate during which a time is planned for selected free lectures, but there will also be room for reflections and exchanges that arise among young lawyers.

## **1.- GENERAL REPORTS**

Each Regional Subsection attending the Congress (America, Europe, Asia, Africa and Oceania) will present, as planned in the timetable, a report on the regional situation concerning: A) "The regulation of the individual relationship of work in times of transformation of productive processes", B) "Collective action in the face of

changes in the ways of work" and C) The challenges of Social Security: How to protect everyone all time?

A regional report will be presented on each of the 3 topics mentioned above.

The Regional Reports will be in charge of the Regional Coordinators (for America, Ignacio Zubillaga, and for Europe, David Carvalho Martins, Jakub Tomsek and Nicola Gundt) and the representatives of the remaining Continents.

The presentation of the regional reports will be held on the days and times set out in the Schedule. Each regional report, as far as possible, will be carried out by three young lawyers per continent. One of them will have 20 minutes to develop the status of the situation on the continent and then two speakers will talk about positive and negative aspects of the regional status described, respectively.

Regional reports will have a maximum length of 10,000 words and must be presented in one of the two official languages of the event (Spanish and English), adhering to the following style guidelines: Times New Roman font, size 12, line spacing 1.5.

The deadline for delivery of regional reports shall be **31<sup>st</sup> March 2020**. Reports will be received in email address [jovenessmdtss@gmail.com](mailto:jovenessmdtss@gmail.com).

**a) Abstract**

Interested parties should submit an individual proposal that develops one of the topics proposed by the Organizing Committee which abstract shall have a maximum length of 500 words (including notes and reference). Proposals will be received in the email address [jovenessmdtss@gmail.com](mailto:jovenessmdtss@gmail.com), until 1 March 2020 for evaluation and selection. The document must be accompanied with a curricular biography, as well as contact details, country of origin and institution of origin.

**b) Lectures**

The evaluation of lectures will be carried out by a specialized committee on the subject, which will review the drafting of any of the topics proposed by the Organizing Committee, as well as the appropriateness of the approach used. The decision of the jury shall be notified to the authors of the selected lectures.

From the lectures presented during the Congress, the organizing committee will select those that will be part of a publication in Mexico.

The selected lectures must be submitted by 1 april 2020.

Free lectures shall not exceed 5,000 words, and must be written in Spanish or English, adhering to the following style guidelines: Times New Roman font, size 12, line spacing 1.5.
