

Norwich Road Runners AGM, 28th November 2019, held at Sprowston High School 8pm

There were approximately 90 club members at the meeting plus the current committee: Gary Cooper, Jodie Causer, Chris Harrison, David Field, Mark Betts, Chris Amos, Jessica Behan, Mick Powell, Stephen Pizey, Kathy Easter, Alma Simmons, Stacey Harper, Glyn Manton, Beryl Knowles.

Chris Harrison welcomed everyone to the meeting and led us through the handout/power point presentation.

Club training — much work has taken place to establish the pace groups and programmes for Tuesday evenings. Group leaders/coaches have now been identified and programmes are being agreed and shared. Our aim is to offer a range of training options with a view to people knowing in advance what is happening at sessions.

Monday and Thursday sessions are going well with the introduction of Couch to 5k group and new road routes from our new base.

Juniors – led by Alma Simmons, Elies Mann, Ally Hadden, Ray Lindsay. Another successful year, with teams taking part in Sportshall, Parliament Hills and EKIDEN. Many Juniors took part in the first chip timed Junior race at The Dinosaur Park last March.

Alma gave special thanks to Maureen Hamis who has just stepped back from the Junior Committee. Maureen has worked tirelessly for the Juniors, in particular, organising the volunteer rota — a difficult but essential task. Samantha Wall is taking this over and Alma asked for people to put themselves forward by contacting her or one of the Junior leaders.

Ally talked about how the importance of Transition runs had helped the older Juniors in strength and confidence to take part, with support, in Senior sessions. This cannot be done without volunteer help and more help is needed.

Social team – Christmas events as listed. More help in organising social events is always welcome.

Chair's report – Gary was pleased to mark the fact that founder members and club legends, Richard Sales, Mick Powell and Ray Lindsay, were still active in the club. He also noted that there were a significant number of

members who were attending their first AGM. Gary said he was particularly proud of how the Junior section of the club has developed and thanked the leaders.

The club has grown hugely to around 500 members — and the committee has not expanded in proportion. To keep the club running as it does and to take on new challenges, we need lots of volunteers and Gary asked members to consider stepping forward to do a bit extra at one of our events, help with the Juniors or consider joining the committee.

Treasurer's report – see handout. It is worth noting that from the annual membership fee of £36, only £20 comes to the club, the remainder going to UKA for insurance and registration purposes.

Kathy explained that the cub had seen many changes during this year and had recorded a loss of £15,000. The move to Sprowston had had additional costs to those planned and we had invested in new, and much needed, equipment. For the first time, the club had paid for first aid training as well as continuing to support members through leadership/coaching programmes.

Glyn proposed three amendments to the Constitution – change of address, the addition of four new committee roles and an increase in the number and flexibility of committee members. All changes were proposed, seconded and accepted unanimously.

Election of committee - if a person has been on the committee for more than 5 years, they can be re-elected. Other committee members, if willing to stand again, are elected en masse.

Gary Cooper – proposed, seconded and re-elected as Chair.

Kathy Easter – proposed, seconded and re-elected as Treasurer

Mick Powell – proposed, seconded and re-elected as Committee member

All others were re-elected en masse.

Mark Betts is standing down as Membership Secretary after incredibly hard work in this role. He is succeeded by David Hender. Chris Harrison is stepping down from the committee – huge thanks for all his work on getting our communication systems to work more efficiently.

Nick Gurney has been put forward as Vice Chair – this was proposed, seconded and accepted unanimously. Gary Stevens has volunteered to join the committee and has been accepted. Jess has volunteered to take a lead on training/coaching.

There were no questions submitted in writing prior to the meeting so questions/comments were invited from the floor.

One member commented that although the club has seen a loss this year, all spending is put back into the club, providing opportunities for members to travel to races, take part in track training, do coaching courses etc. The club invests in its members so the membership fee is excellent value.

It was suggested that we have a survey to get feedback on the move to Sprowston – Kevin Rowe said he would help with this. He is also working on streamlining our Facebook communication and would be feeding results of this back to the committee and club.

Club awards – voting opens on 29th November, closing on December 18th. Club awards will be presented at the Christmas Dinner.

There being no further comments, this closed the AGM.

VLM ballot

Glyn explained that due to an administrative and timing error on his part, the club has not got any ballot places for 2020. Glyn apologised wholeheartedly for this and received much support from all present.

The committee had had an emergency meeting and, as a gesture of goodwill, voted to offer a paid place in a UK marathon of their choice to the four people who were drawn in the ballot. This would not prejudice their entry into the ballot next year for VLM 2021.

Proposed change 3 - Current constitution limits committee to 12.

The following change is needed

The Management Committee shall be composed of up to eleven (11) officers of the club (see above) and up to five (5) members, all will be elected at the Annual General Meeting.
