September priorities

a. Move to Sprowston- Update. Any outstanding matters?

General discussion about facilities, what we have booked, where on the field, lighting, toilets.

Action: David Field to speak to Lisa (Sprowston) so we are clear about what areas of field we have booked and when. To see if we can agree a meeting point that is the same for each 3 nights where new members can go to. David to find out if we can have some form of signage at the school.

Action 2 -Decide on a meeting point for new members which is same for all 3 days.

Produce map that can be emailed. Have signage made that can be put out on the night

 b. Club Captains report and club races (Chris/Stacey)- Last update (newsletter) well received. Nothing to report since

General discussion about minibuses etc.

Action Team captains to be allowed to spend £70 per team on water/food. Captains to get sizes of hoodies and Chris will order for all 3 teams. Cost of £10, club to pay shortfall.

Action- Committee decided that kit to be sold at club on first week on month. Glyn to look to recruit someone to keep stock and reorder.

General discussion about categories including having a new award for serving the club in honour of Lynda Moore.

Action – Chris Harrison will make suggestions of categories and voting system at the next meeting

14. Report on safeguarding (Beryl/Chris) What needs to be done to action Beryl's report?

Action – Beryl to complete and liaise with David Field to have loaded onto the website

15. GDPR- Glyn to handover to Chris by next meeting.

Action-Glyn to hand over documents he uses for Chris to check update.

16. Coaching strategy at NRR

Discussion about what is needed to cater for all runners especially our 'group a runners' some of which have not been training at club since move. Discussion about having the committee set the strategy and plan Tuesday nights (Efforts sessions) in quarter blocks using pace groups as per Chris Harrison's proposal.

Look to initially make more use of UEA track to free up space at Sprowston but target mainly pace groups A/B which C and D being able to use the sessions on an open night. Discussion of increasing track bookings from current 10 per year to



say 20. Jodie is in discussion about sharing track use with NG to reduce costs.

Discussion about the need for more I2 coaches and the fact that with the proposed strategy we would not need one Head Coach but Lead coaches to work with each efforts group. Monday night can continue as is and Thursday can be run on a rota basis. General discussion that as a road running club that road efforts/hill efforts are also well received so should also be part of the training plan.

Action. Jess/Chris H to lead on strategy and to facilitate the next coaches meeting (3/9/2019) by presenting the strategy approved by the committee tonight and then asking coaches to lead the groups and run leaders to help deliver.

Action. The need for more I2 coaches discussed. Names discussed at meeting to be discussed. Ally is first priority. (Following meeting, we have investigated the possibility of running a in house course to get 5 of our members identified by the committee through L2 in the next 6 months)

Points for further discussion. Need for a committee rota for Tuesday/Thursday to start night and introduce sessions. How we allocate new members into groups. How we let members change due to different training plans. Who do members contact about coaching issues? How do we deal with XC national/local events? How to we administer and communicate- Do we need a Coaching Coordinator to liaise with the Lead coaches and control rotas/member communication?

Proposal Norwich Road Runners will support its members to be competitive and challenge themselves and others at all levels, with NRR featuring regularly in local individual team awards for road races and XC. We are an inclusive club where all members are helped by other members to identify and achieve their running goals
