



Dr. Malone said that early on in the pandemic, he believed that what he could contribute was bringing repurposed drugs to market.




About mRNA Vaccine

I started going down the rabbit hole learning about mRNA vaccines. Actually, the concept is very simple to understand without professional medicine knowledge.



My Testimony

- It is not a rocket science to understand the mRNA vaccine technique at the conceptual level.
- I became aware of that the mRNA vaccine is the first medicine/drug in human history that enables a human body to produce new substances (spike proteins) that otherwise would not exist in the human body.

Highest Honor Bestowed for Foundational Discoveries that Gave the World a Vaccine to Fight COVID-19 Pandemic

PHILADELPHIA – The University of Pennsylvania messenger RNA pioneers whose years of scientific partnership unlocked understanding of how to modify mRNA to make it an effective therapeutic—enabling a platform used to rapidly develop lifesaving vaccines amid the global COVID-19 pandemic—have been named winners of the 2023 Nobel Prize in Physiology or Medicine. They become the 28th and 29th Nobel laureates affiliated with Penn, and join nine previous Nobel laureates with ties to the University of Pennsylvania who have won the Nobel Prize in Medicine.

I am a Christian and I truly believe that a human body is a delicate and complicated design by the Creator, the God. No matter how intelligent and creative our human beings are, we are always limited as human beings and will never be able to fully understand such a delicate and complicated design like the human being body. In other words, our body is beyond our human being's capability to be modified or manipulated structurally or functionally, even in a seemingly insignificant way. Otherwise, there may be unexpected or even catastrophic results. As for vaccinations, I have received all the required traditional vaccines and I have no problem with injecting them into my body because they are "inactivated viruses" that are produced outside my body. I am even amazed by the story of how "cowpox" was naturally discovered as the vaccine for preventing smallpox infections. However, I have serious concerns about the COVID-19 vaccines because they are used to let my body to self-produce "inactivated virus" inside my body, not like what traditional vaccines do. To my understanding, by God's design, my body's immune system shall only respond to "inactivated viruses (vaccine)" or viruses that get into or invade my body externally, but the COVID-19 vaccines will let my body's immune system respond to virus-like substances or proteins that are self-produced inside my body. This seems to be a very significant modification or manipulation to what and how God designs my body to be. Therefore, I believe taking the COVID vaccine is against my religious faith related to how my body should be treated according to God's design and respectfully request that I am exempted from the COVID-19 vaccination. To me, this is not only a religious exemption request but also a scientific exemption request because I believe my religious faith is compatible with science.



My Theory of mRAN Vaccine Side Effects

- The current mRNA technique don't know how to limit the flow of mRNA vaccine nanoparticles in a human body.
- When mRNA vaccines are injected into a human body, the mRNA vaccine nanoparticles don't stay locally in the local muscle area of the injection site.
- Instead, they may go into the blood system and flow to many parts of the body: heart, brain and other organs.
- mRNA vaccines produce spike proteins in organs where they reach.


A: You must have a complete and crystal clear understanding of how every biblical teaching benefits yours and other people's lives on earth.
