- an event calendar for the months of October and November has been uploaded to our website and events will also be announced on our Instagram page

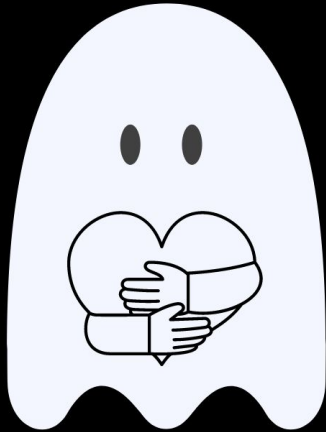

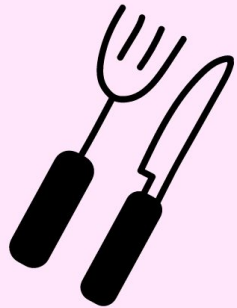
