The Pastor's Report

The New Year began with my silent retreat at the Abbey of Gethsemane in New Haven, Kentucky. It is the home of Trappist Monks and an experience of the Holy that is unique. The silence was an invitation for me to listen. How am I as husband, father, pastor? Where is God? How is my vocational calling? Where is First UCC called to be these days? How am I to lead, to listen, to learn?

*Hello darkness, my old friend
I've come to talk with you again
Because a vision softly creeping
Left its seeds while I was sleeping
And the vision that was planted in my brain
Still remains within the sound of silence*

I emerged from the silence and entered a world of sounds. Renee Good had been shot four times by an Immigration and Customs Enforcement (ICE) agent. Sounds of chaos, fear, anger, disgust, protest, and excuses filled our airwaves, city halls, streets, and yes churches.

We do not hide in silence from the truths of what church is called to be. We are to be places of healing, of sanctuary, of forgiveness, and of love. In our prophetic stance to “BE THE CHURCH” we need to sit with the sounds and images around us and listen for the way that unites us as siblings – brothers and sisters. The Sunday immediately following Good’s death, we had Heleana Theixos, PhD in Business Ethics, speak to us about power dynamics and ethics and the moral injury we can incur. When we are in positions of power, we will abuse that power, Theixos says, and do things that go against even our own moral and ethical values. Deep breaths... Look into the eyes of the other. See the face of God. Can the ICE agent do this with the protestor they encounter? Can the protestor look into eyes of an agent and say the same? Can those who are immigrants be seen as they truly are? God’s beloved seeking life.

*And in the naked light I saw
10.000 people, maybe more
People talking without speaking
People hearing without listening
People writing songs
That voices never share
And no one dared
Disturb the sound of silence*

Two weeks later we were there again. Alex Jeffrey Pretti was killed with rapid fire from the ICE agents. Pretti's backstory is of a VA nurse who was known for his compassion, humor, and dedication to be a healer at work and in community. We cannot remain silent. Trappist monk Thomas Merton lived in community for 40+ years and practiced the art of silence. Yet his voice was loud and clear throughout his prophetic writing. Through his writings, he spoke out against war. He reminded humanity of our call to hospitality and welcome of the stranger. He challenged the church to go beyond the comfort of Catholicism and listen to the voices of Buddhists, Jews, Muslims, people of no religious faith. He wrote volumes of the inner life and how we are called to practice ways of justice, truth, contemplation, and action.

*Fools said I, "you do not know
Silence like a cancer grows
Hear my words that I might teach you
Take my arms that I might reach to you"
But my words like silent raindrops fell
And echoed in the wells of silence
And the people bowed and prayed
To the neon god they made
And the sign flashed out its warning
And the words that it was forming
And the sign said
"The words of the prophets
Are written on the subway walls
And tenement halls"
And whispered in the sound of silence*

Paul Simon and Art Garfunkel wrote "The Sounds of Silence" for their first album in 1964. It was following the events of November 1963 with the Kennedy assassination and be an anthem of the 60s as violence, protest, and change were all around. No matter the era, the song reflects the feelings of alienation and disturbance. It speaks to the pain and sadness of the times. Where do we find the words of the prophets, the songs of protest, the actions of justice and love these days? We take in much these days. Let it stir in us compassionate and urgent responses of peace. What better time than the month of February. A month that sees us begin our holy season of Lent. Prayers to pray; actions to take; and blessings in our silence to contemplate this month.

While there were good moments in January for the church's music, media, and faith formation realms, I'm looking ahead to what February has in store.

After a longer winter break than we expected (thank you, Mother Nature), I'm pleased to welcome back the chancel choir and handbell choir. The chancel choir starts the month off with a moving anthem, "Hold On," that serves as a reminder to us all that we are not alone in the struggles of life. On the 8th, the choir sings "Love Never Leaves," which reflects on those who have left this world but still live on in our hearts, minds, and all that we do. On the 15th, they will sing a very fitting anthem, one of my absolute favorites: "In the Bleak Midwinter." They close out the month with "O God, Most Holy," which incorporates the melody of the very famous, "Panis Angelicus."

The handbell choir rings on February 15th, performing an arrangement of "Londonderry Air" (also known as "O Danny Boy") which incorporates both the handbells and hand chimes. I will continue to say that it is never too late to join either group if you have an interest in joining in on the fun! The groups are low-stress, high-fun, and I do all that I can to ensure even the most novice musicians are able to perform at their best. Talk with me or a fellow choir member to find out more!

Other media projects I will work on this month include receiving bids for a new sound system and the installation of two projectors. Also, as we hosted many events in 2025, none of these outside folks used our sound system – they brought in their own boards, microphones, and accessories for the MLK service and Bishop Paula's ordination. The musicians at the Pride service decided to sing without microphones... As we continue to grow, using our facilities more for both church events as well as community gatherings, an updated system for audio and visual is of high priority to me. One final thing to note – I will be away from February 24 through March 8. I thank Tricia Lenhof and Jeanne Phillips for their musical talents while I am away. Also, thanks to Bernie Wehman for his continuous expertise on the iPad for livestreaming, as well as to Mason and Chris Baldwin for their assistance in unpacking and packing up the projector, iPad, and laptop. Finance Committee News

January 2026

Recap of Church Facility Projects presented at the Congregational Meeting:

Necessary Repairs:

1. Salt has ruined the bottom of the wall of bricks to the right of the entry door to the fellowship hall, between that door and the left doors to the narthex. A separate contract to repair the wall is necessary. We expect this project to be expensive.
2. The parking lot needs all existing cracks repaired and needs to be resurfaced.
3. The walkway on the north side of the church that goes around the kitchen to the hallway needs improved drainage. The wall that supports this sidewalk has brick and mortar damage.
4. Twelve pillars support the entrance overhang. They need new mortar and a few new replacement bricks that were destroyed by salt when we were removing snow and ice. We need a contractor to do the work, but the expense is reasonable.
5. The bell tower has several missing blocks/bricks and needs to be repaired.
6. Duke Energy required us to move electrical components from inside the church to the main electrical reception box that is near the parking lot. They also required us to build solid barriers between the box and the parking lot to prevent damage to the box and the components.
7. Undetermined work is needed to address exterior water issues. The facilities team is collecting necessary information.

Nice to have projects:

1. Installing automatic doors to the main entrance doors and first floor restrooms.
2. The sanctuary audio and video system needs updating.
3. Shorten designated pew(s) to accommodate wheelchairs in the sanctuary, out of the main aisle.
4. The outdoor playset needs replaced.

- Ed brought up there are several small water issues which need to be addressed. He was reminded that we need to have 2 – 3 estimates (per the Constitution) and those presented to the Board,

- The sealing of the parking lot was again mentioned and Ed had a bid of \$1,800.00.
