GDPR Regulations Article 6 (b) processing is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract.

<u>Information collected</u>

Property data linked to the tenant's name only is also held on the accounting software, both on the PC and Sage's server.

Retention periods

As a tenant the data collected will be retained for the duration of the tenancy, and then confidentially destroyed within 6 months of the end of the tenancy.

Bank Standing Order Forms are passed onto the relevant bank as soon as possible, and no copies of the data are retained.

Who it is shared with

The data provided will be accessible to the Company Secretary and Administrator. It will also be available for the Directors of the Association to review.

Name, address and contact data will be provided to contractors as necessary.

Name and address data will be provided to the local council for council tax purposes, and to the utility companies at the start of the tenancy.

Where applicable rent data may also be supplied to councils for housing benefit purposes.

In the event where legal proceedings may occur, relevant data may be shared with the Association's solicitors and the courts

Your rights

You have the right to know what data is being held about you, and to request details of that data.

You have the right to rectify any incorrect data held.

You have the right to have any irrelevant data deleted.

You have the right to know how that data is being used, and who it is being shared with.

You have the right to restrict the processing of the data.

You have the right to data portability.

You have the right to withdraw your consent at any time.

You have the right to complain to the Information Commissioners Office if you feel that your data is being used incorrectly in any way.
