

Privacy Policy

Protecting your private information is our priority. This statement of Privacy applies to www.mavenpv.com, and Maven Pole Vault LLC and governs data collection and usage. For the purposes of this privacy policy, unless otherwise noted, all references to Maven Pole Vault LLC include www.mavenpv.com. The Maven Pole Vault LLC website is an ecommerce and information website. By using the Maven Pole Vault LLC website, you consent to the data practices described in this statement.

Collecting of your Personal Information

In order to better provide you with products and services offered, Maven Pole Vault LLC may collect personally identifiable information such as your:

- First and Last Name
- Mailing Address
- E-mail address
- Phone Number

If you purchase Maven Pole Vault LLC's product and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. Use of your Personal Information

Maven Pole Vault LLC collects and uses your personal information to operate and deliver the services you have requested.

Maven Pole Vault LLC may also use your personally identifiable information to inform you of other products and services available from Maven Pole Vault LLC and its affiliates.

Sharing of Information with Third Parties

Maven Pole Vault LLC does not sell, rent, or lease its customer lists to third parties.

Maven Pole Vault LLC may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. - Exercise free speech, ensure the right of another customer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.
