## Minutes:

#### **Treasurer's Report:**

• We have received our first check on the Opioid settlement. Total received so far is \$69,720.76. I will be researching the stipulations and guidelines on the monies uses so a discussion can be held at the next meeting.

• Billing conversion has come to a halt for a few weeks. There were some issues with billing codes completed by CUSI not calculating correctly. Hopefully, training can start back up next month and then the conversion will be completed for March/April 2024.

• The office will be closed 1/15/2024 in observance of Martin Luther King Jr. Day. Trash services will be one day late the week of 1/15/2024 except for Friday.

## **Public Comment:**

- Resident & Former Councilor Rezin Hudkins noted the following:
  - The TONF lost another police officer and he would like to know the plan for another police officer to help create police coverage 24/7.
  - Mentioned that the Opioid Settlement is \$700K over 15 years and that Nutter Fort PD should consider hiring a police officer to get the DARE program in the schools.
  - Steve Johnson, a 31-year veteran of the police force, most recently Harrison County Sheriff's Department spoke up and stated that there are two reasons officers leave the police force from what he has seen: money and morale.
  - This lengthy discussion prompted a work session to be held prior to the next council meeting on 1/23/2024 at 5:30pm regarding police coverage.
- Resident & Former Councilor Rezin Hudkins also noted:
  - He had to input the order for bricks and would like council to help review the order for accuracy ASAP. Information was originally sent to Natalie Haddix and was subsequently forwarded to council, as Charlene Louk and Bryan Gonzalez advised that they would assist with this.
- Resident Jennifer Robinson inquired about water meter issues with her residence. Mayor Sam Maxson advised that she needs a different cover on her meter and would follow up with her.
- Resident Dennis Dutchess brought up the following:
  - Issue with the lack of a white line on Illinois Avenue and by Freedom Baptist Church. It is hard to see where the road ends. Mayor Sam Maxson was going to look into it.
  - His furnace has a calcium deposit issue this year. He was advised to contact PW Supervisor Taylor Keith regarding testing at his residence.
