

**Board of Canvassers
Nutter Fort
June 15, 2015**

The board of canvassers of Nutter Fort met, Monday evening, June 15, 2015, in council chambers with the following members present: William Benincosa, Donald Webster, Nathan Rohrbough, Sam Maxson, Bruce Kidd, and Karen Phillips. Absent was Stephen Korn. Also present was incoming Recorder Charlene Louk.

The meeting was called to order by Recorder Sam Maxson at 7:00PM.

- Bruce Kidd motioned we set the bond for any possible recount at \$200. Following a second by William Benincosa, the motion was approved by unanimous vote.

The voting "can" from precinct #6 was unlocked and the contents removed. The number of ballots received was 759, which included 510 ballots unused, 247 voted ballots (2 were provisional), and 0 spoiled ballots. Upon hand counting of the ballots, the numbers matched those reported by the election officials on their statement of Ballots used.

- Upon review of the 2 provisional ballots, Donald Webster motioned that they not be counted because neither were registered voters in precinct #6 or Precinct #3. After a second by Karen Phillips, the motion was approved.

Results from Precinct #6 remained unchanged.

The voting "can" from precinct #3 was unlocked and the contents removed. The number of ballots received was 311, 247 ballots unused, 64 ballots voted (which included 1 provisional) and 0 spoiled ballots. Upon hand counting of the ballots, the numbers matched those reported by the election officials on their statement of ballots used.

- Upon review of the 1 provisional ballot, Donald Webster motioned it not be counted because the voter was not registered in precinct #3 or precinct #6. Following a second by William Benincosa, the motion was approved.

Results from precinct #3 remain unchanged.

- The meeting of the board of canvassers was adjourned at 8:23PM after a motion by Donald Webster and a second by William Benincosa.

If no call for a recount is received by 8:23PM, Wednesday, June 17, 2015, the election will become final and the results (see page 2) certified as official.
