Treasurer's Report:

- LAST REMINDER Flu Shot Clinic will be held 10/11/2024 from 9am-10:30am.
- There was a conversation last week on the Halloween Fall Festival with Karen Phillips. I thought that maybe we could advertise that the Town will be accepting donations made for hurricane victims. I would like to have a charity organization to give them to and wanted council's input. I was thinking Samaritan's Purse or Cajun Navy 2016. These organizations are some of the "boots on the ground" and go wherever is needed in the United States.
- The cybersecurity risk assessment was completed today (10/8/2024) on our water, sewer, and billing operations by CISA (US Cybersecurity and Infrastructure Security Agency.
- I received an email concerning PEIA increases for the next FY. We are looking at a 14% increase in premiums along with deductibles and out of pocket maximums are increasing by at least 100% to employees. I am scheduling a supervisor's meeting to come up with some options to present to council.

 - o Tickets are still on sale for the Ultimate Giveaway.
 - o Sent two personnel down south over the weekend to assist with efforts due to Hurricane Helene.
 - o Donations for Hurricane Helene victims are being accepted at Vincent Memorial and Freedom Baptist Churches. Linda Griffith is also accepting donations for a limited time period at the Nutter Fort Post Office.
 - o RCBHS Homecoming Parade, coordinated by Robert C. Byrd High School, went through town 10/2/2024. It was a very successful parade from the amount of people lining the streets.
