CO QUICK REFERENCE

Revolutionary FAR Need to Know

 Sole-Source awards may be accepted by the SBA when the acquisition is for a Tribal-Owned small business or Alaska Native Corporation. [FAR 19.805-1\(b\)](#)

 Tribal 8(a) sole source is authorized by statute – no justification required for Tribal 8(a) sole source up to \$30M civilian and \$100M for DoW. [FAR 808.1-\(a\)](#); [FAR 6.302-5\(b\)\(4\)](#); [DFAR 219.808-1\(a\)](#); [DFAR 219.303-1\(a\)](#); [FAR 19.805-1\(b\)](#)

 Follow-on sole source contracts to the same entity owned 8(a) are allowable. [FAR 33.103](#)

 Alaska Native Company 8(a) sole-source awards are PROTEST-FREE under [13 CFR 124.517 \(a\)](#) ensuring smooth contract initiation without delays from protests. Also [DFAR 206.303-1\(a\)](#)

 Flexibility and reliability through direct negotiations allows us to truly understand your mission goals and competitive threshold exemptions allow for uninterrupted workflow.

 For acquisitions above the simplified acquisition threshold, Contracting Officers shall first consider the 8(a) program before considering small business set-asides.

 Scope changes are allowable for existing 8(a) sole source contracts. [FAR 33.102](#); [FAR 33.101](#)

The Agency Program Manager chooses our company to perform the work and submits a procurement request to the Agency Contracting Officer.

Your Agency CO sends a Letter of Intent to Award to our SBA BOC. The project description is included in the letter.

PROCESS

03

The SBA issues a Letter of Acceptance to your Agency. Your Agency CO notifies our company.

FINISH

04

We collaborate on the development of the work plan.
Finalize negotiations.

AWARD

05

The entire process can take less than 7 days!
