

## TOWN OF TEXAS 2024 PROPERTY TAXES

To receive the lottery credit your home must be your primary residence and you must have lived there January 1, 2024.

### PAYING YOUR PROPERTY TAXES:

- The payment in full, or first installment, is due on or before January 31, 2025.
- Checks should be made payable to: Town of Texas include bill # in memo.
- **\*\*\*Checks must be for correct amount to avoid late payments and penalties.**

Please complete the enclosed form and return with proof of rabies vaccination with the appropriate payment to the Treasurer by April 1, 2025.

**A dog license will not be issued if proof of rabies vaccination is not included.**
