Justin Thoma requested a hearing before the TOWN OF TEXAS BOARD OF APPEALS for the property located and described as: 243411 BUFFALO RIDGE ROAD (formally N 73rd St) located in Section 14 T30N R8E Pt of SW ¼ SW ¼ S 148.5 OF W 290' of that part Lyg E of Hwy, Running N&S of forty listed on the assessment roll as 1 acre. The party is working with an adjacent owner to reconstruct the property to be less non-conforming. Justin requested to add to the structure on the north side but the side yard setback didn't meet ordinance of 25', however the following excerpt from the Zoning Ordinance would allow a change in the original parcel by reconstructing the parcel to meet setbacks. The parcel would still be non-conforming, as a one acreage parcel in Agricultural Zoning. The size would not change but the dimensions would.

Chapter 17.21 (2) No Existing lot shall have boundaries altered in any way without the resulting parcel being in full compliance with this zoning code and zoning district in which the parcel is located. The Board of Appeals may waive this requirement where there is not sufficient contiguous ownership to comply but where the parcel to be created will be less non-conforming.
