**IMPORTANT ANNOUNCEMENT FROM THE FL WATER DISTRICT
NOTICE OF PUBLIC HEARING**

Pursuant to A.R.S. § 38-431.02, notice is hereby given to the Members of the

Forest Lakes D.W.I.D. Board and the general public that the Board will hold a Public Hearing, on Thursday August 22, 2019 beginning at 10:00 AM. Please note the change in address for the meeting will be held at the Forest Lakes Community Center located at 1111 Merzville Road in Forest Lakes, AZ 85931

The purpose of the hearing will be to hear from the public on the proposed added line item to customer's bill of approximately \$3.71 help for the Little Colorado River Coalition Fee. The proposed \$3.71 will be adjusted annually depending on the demand of the LCR Coalition.

Public Participation: The public is invited to speak on any item or any area of concern. Please hold comments on Open Forum items until appropriate times. Items presented during the hearing cannot be acted on by the Board of Directors. Individual Board Members may ask questions of the public, but are prohibited by the Open Meeting Law from discussing or considering the item(s) if not officially placed on the Agenda. Individuals are limited to a five-minute presentation and must sign in to speak and must come forward so comments can be recorded for the record.

Forest Lakes Domestic Water Improvement District has been involved in the Little Colorado River Coalition since 1998 with Mr. David Brown and his firm Brown and Brown Law. LCR was formed with regard to the general adjudication of all rights to use water in the Little Colorado River System and Source.

Mr. Brown has had to hire other Law firms over the years to help with the increase litigations and expert witnesses. There are approximately 22 entities involved in the LCR Coalition. Each entity pays a percentage of the total. Forest Lakes DWID in the last 21 years has gone from paying \$5000.00 a year to \$40,000.00 a year.

As Forest Lakes DWID cannot get into details about the litigation without a lawyer present, we do want our community to know the importance of the litigation and what is at stake. (i.e.) water supply and water cost. Forest Lakes DWID has set up a public hearing to talk about adding a line item to customer's water bills. Mr. David Brown with Brown and Brown Law will give a presentation about the LCR Coalition. August 22, 2019. 10:00 am at 1111 Merzville Rd.

Cost is a can of food per person to donate to the Heber Food Bank.


