CELL TOWER/VERIZON UPDATE

On May 18th, I met with Pinnacle Consulting, the Verizon Wireless representative and DW Tower personnel to discuss the next phase of construction. The final phase will consist of fabrication and installation of antennas, communications equipment that will go into the building and power connectivity after APS sets their meters. The anticipated completion for this portion of work is 4-6 weeks. Once this work is completed, Verizon will activate and test the equipment to assure operational readiness and identify any potential issues prior to full activation.

The anticipated Go-Live date for full service of the Tower is anticipated to be mid-July at the earliest, first part of August.

I should remind everyone that tower construction experienced significant delays due to rain and snow this past winter.

IMMEDIATE OPENING ON FOREST LAKES FIRE DISTRICT BOARD

At our Board meeting held May 16, our friend and fellow board member, Joe Ruet, announced his desire to resign from the Forest Lakes Fire District Board of Directors. Given his first responder background, Joe feels he could better contribute to the Forest Lakes Fire District as a paid-on-call participant.

Joe's term expires November 30, 2022. Therefore, it is incumbent on the Board to appoint a replacement to fill the remainder of his term and we are seeking Forest Lakes Community members who have interest to apply for this opportunity. Residents who wish to be considered for appointment must be registered voters of the fire district. Switching registration is easy and can be

accomplished on-line.

Serving on this Board requires that you attend monthly meetings (required by law), come prepared for these meetings by reviewing pre-distributed documents, participating in discussions and voting on motions. Excluding travel and any special assignments, this role requires about 5 hours per month. Joe's replacement, like the rest of us, will be a public official, appointed to fill Joe's remaining two-year term rather than elected. Note that as a public official, this is a volunteer, unpaid position.

The individual we are looking for should have a professional background, be diligent in performing their duties, get along with others in a team environment, have appreciation for the role the Fire District plays in maintaining public safety in our community, be able to devote the needed time and be available to attend the monthly meetings. Meetings can be attended telephonically.

One other requirement is attendance at the annual Arizona Fire District Association Conference, a training and networking event, held each January, in Laughlin. Expenses are paid for the board member and you may bring a guest, but their expenses are not covered.

By way of full disclosure, while we are reaching out to the community and encourage anyone reading this who has an interest and meets the requirements to apply, please know that, at this time, we do have one qualified applicant. If no one else steps up, this individual meets the requirements to be appointed to fill this opening.

Our Fire District is in very good shape. We have a strong leadership team and we are well positioned operationally, strategically and financially. Therefore, we encourage you to bring your skills to help us run this important community resource.

If you are interested, please send me an email, based on the criteria above, stating why you are interested and how you think you may be able to help govern the District. FLFD Board of Directors Also Looking for Board Candidates

The Forest Lakes Fire District leadership team consists of five board members plus the Fire Chief, who is hired by the board. Board members are elected by the residents of the District, and serve 4-year terms. Terms of office expire in November of this year for two of the current board members. The FLFD leadership team is providing advance notice so prospective candidates can apply for the upcoming open board positions.

Candidates for office must be registered voters of Coconino County and the fire district. Residents interested in board membership who are not registered to vote in Coconino County will need to switch their registration.

By statute, the Forest Lakes Fire Board is required to hold monthly meetings. We have a summer schedule (March through October, 3rd Saturday of the month at 10:00 am) and a winter schedule

(November through February, 2nd Saturday of the month at 10:00 am). Board members may attend telephonically.

Board member training is required by Arizona statute and is offered semi-annually by the Arizona Fire District Association (AFDA) in Laughlin in January and in Phoenix or Tucson in June/July. The FLFD office staff has copies of the current AFDA handbook for those interested in a more detailed look at fire district operations.

Current board members are willing to meet one-on-one with prospective candidates to provide answers to any questions, to relate their personal experiences regarding board membership and to explain why they find serving the community as board members to be a rewarding and fulfilling experience. Since the relationship of the Fire Board and the Fire Chief is critical to the successful operation of the Fire District, Chief Rodriquez has also offered to meet with candidates. The FLFD Five Year Strategic Plan (STRAP), available on our web site at www.flfdaz.com, is also an excellent source of information on department operations.

Formal applications to appear on the November ballot must be submitted to Coconino County between June 8th and July 6th. FOREST LAKES FIRE DISTRICT AUXILIARY REPORT

Due to social distancing, we have cancelled our June Auxiliary meeting. Also, as we had previously announced, we have had to abandon our usual summer fundraising activities, i.e., ice cream socials, etc., until further notice.

As an alternative, Casa Rey's Food Truck came to Forest Lakes over Memorial Day weekend and was a huge success. We would like to thank all of you who purchased food from them over the holiday weekend. As noted in our FB posts, a portion of their proceeds is being donated to the Forest Lakes Fire District Auxiliary. We greatly appreciate Casa Rey's support.



This year, the Fire Board requested a donation towards a Lucas Chest Compressor (see photo) for the Fire District, with an approximate cost of \$15,000.00. Here is information provided to our Board by Forest Lakes Fire District Chief David Rodriquez on how this piece of equipment will benefit our team of First Responders: "With our crews on high alert and additional safety precautions in place due to COVID-19, our hand to body interactions increase our emergency staffs exposure to not only COVID-19, but all other communicable diseases. This Lucas device has been around for a couple of years and studies have indicated a higher survivability rate for

patients that experienced sudden cardiac arrest. Having this component in our toolbox provides a force multiplier due to our smaller response model, frees up personnel to provide adequate airway management and allows the sometimes single paramedic to administer Advanced Cardiac Life Support medications in a timely manner. The device will reduce our hand to body exposure once applied, increasing circulation that is critical with full cardiac arrests."

Because we are so limited on fundraising efforts this summer, we are continuing to reach out to the Forest Lakes community. Do you know that when you make a donation to the Forest Lakes Fire District Auxiliary, that donation can be tax deductible? Do you also know that when you make a donation to the Auxiliary that is earmarked for a specific need, i.e., the chest compressor, that donation goes directly to that purchase? Please consider making a donation so that we may continue to offer financial support to the Fire District in their efforts to purchase this much-needed equipment. 2020 Forest Lakes Self-Serve Community Cleanup Days - Recap from Ron Hollamon, Coconino County Public Works Department

The 2020 Forest Lakes Self-Serve Community Cleanup Days event was held from Monday, May 11 through Saturday, May 16, 2020. This specialty cleanup event, which was the first in Forest Lakes since August 2016, saw great turnout during its nine-day run with both full- and part-time residents participating to clean up their properties for the summer season.

Public Works was able to utilize property owned by the Forest Lakes Fire District and the Forest Lakes Water Company as well as its own County Maintenance Yard to place roll-off containers so residents could off-load materials at multiple locations. From the start, the event operated smoothly as residents arrived at a steady pace to drop off everything from old treehouses to mattresses. Having multiple locations eliminated traffic concerns and allowed event attendees to practice social distancing in accordance with COVID-19 guidelines from the Centers for Disease Control.

Six 40-yard bulk waste containers, along with one scrap metal and one waste tire bin, were

initially staged for the event. When the event ended on May 16, a total of 12 40-yard bulk waste bins, two scrap metal bins and two waste tire bins had been filled to capacity. In addition to eight refrigerated appliances and 300 waste tires, more than 39 tons of bulk waste was collected during the event, which is a huge amount of waste considering that there are only 1,000 parcels in Forest Lakes.

Due to its distance from Flagstaff, it is always challenging to hold such events and the primary reason why it is so important to have good partnerships with the community. Many thanks to Forest Lakes Fire Chief David Rodriquez for his help communicating with residents and for providing a location for this cleanup event. Kudos also go out to Judy Nelson for promoting the event in the Forest Lakes Newsletters and via her email blasts and to Forest Lakes Water Company District Manager Grant Cooper for providing an area to stage the waste tire bins. Finally, thanks to Public Works operators Clint Russ and David Gastineau for their invaluable assistance operating the backhoe and loader to pack the containers and assist residents with heavy items.

Additional Election workers are needed to open and close the polls, set up voting equipment, sign in voters, distribute and collect ballots, and record and certify vote totals.

To be an Election worker, you must:

- · Be US Citizen and registered to vote in Coconino County
- Be at least 18 years of age
 - Read, write and speak English
 - Attend a training class and pre-election set up meeting
 - Work the polls from 5:30 a.m. to 9:00 p.m. on Election Day

Election workers receive \$100 for the day; \$10 for pre-election setup meeting and \$30 for attending a training session.

In 1983, while a professor of Economics at Boise State University, Barry found his calling as a Professional Speaker as a replacement for Alan Greenspan at an American Bankers Association Convention in Hawaii. Thus began a thirty-five year career speaking on Economics and the Free Market that would take him around the globe. He later joined the National Center for Policy Analysis as a Senior Economist. During the last decade of this career in Phoenix, Barry coauthored a book with his friend, Wayne Grudem entitled, The Poverty of Nations: A Sustainable Solution. This book would also bring Barry back to the classrooms of Arizona Christian University and Grand Canyon University to teach and mentor students.

Barry became a Christian at a young age. He and his wife, Mandy were members of Scottsdale Bible Church and he went on to teach an Adult Sunday School Class and serve as an elder for many years. Barry volunteered on the Scottsdale Young Life Committee and would later serve on the Young Life National Board of Trustees.

Since the mid-1990's, Barry and Mandy have loved their cabin in Forest Lakes. They developed many wonderful friendships in the community. Barry also loved to preach at the Forest Lakes Church on the Fourth of July.

Barry will forever be remembered for his enthusiasm, humor, energy, and kindness. He was generous with his time, talent and resources. Barry wanted to be remembered for leading others to Christ.

Barry is survived by his wife and best friend of 57 years, Mandy Asmus, his son Andy Asmus and wife Nicole, his daughter Angela Yang and husband Paul, and his adoring grandchildren Andrew Asmus, Raegan Asmus, Emilee Asmus and Samuel Yang.
