FLFD Board of Directors Looking for Board Candidates

The Forest Lakes Fire District leadership team consists of five board members plus the Fire Chief, who is hired by the board. Board members are elected by the residents of the District, and serve 4-year terms. Terms of office expire in November of this year for two of the current board members. The FLFD leadership team is providing advance notice so prospective candidates can apply for the upcoming open board positions.

Candidates for office must be registered voters of Coconino County and the fire district. Residents interested in board membership who are not registered to vote in Coconino County will need to switch their registration.

By statute, the Forest Lakes Fire Board is required to hold monthly meetings. We have a summer schedule (March through October, 3rd Saturday of the month at 10:00 am) and a winter schedule (November through February, 2nd Saturday of

the month at 10:00 am). Board members may attend telephonically.

Board member training is required by Arizona statute and is offered semi-annually by the Arizona Fire District Association (AFDA) in Laughlin in January and in Phoenix or Tucson in June/July. The FLFD office staff has copies of the current AFDA handbook for those interested in a more detailed look at fire district operations.

Current board members are willing to meet one-on-one with prospective candidates to provide answers to any questions, to relate their personal experiences regarding board membership and to explain why they find serving the community as board members to be a rewarding and fulfilling experience. Since the relationship of the Fire Board and the Fire Chief is critical to the successful operation of the Fire District, Chief Rodriquez has also offered to meet with candidates. The FLFD Five Year Strategic Plan (STRAP), available on our web site at www.flfdaz.com, is also an excellent source of information on department operations.

Formal applications to appear on the November ballot must be submitted to Coconino County between June 8th and July 6th. THE COCONINO COUNTY COMMUNITY CLEANUP DAYS ENDS THIS SATURDAY, MAY 16TH.

One (1) bin at the County Yard will be designated for appliances and there will be one (1) bin for waste tires on Merzville Road at the Water District.

If bins get full before the Clean-Up days are over, they will get replaced as needed. Please DO NOT leave items outside of a bin.

Arizona Public Service (APS) to Manage Vegetation along Electric **Distribution Lines in Forest Lakes**

APS is scheduled to perform vegetation maintenance work along the 12kV distribution lines that run through the Forest Lakes community starting in May. This work is part of the routine maintenance we schedule every three years in order to reduce the risk of electrical outages caused by vegetation; minimize the threat of fire; and ensure general public and APS-worker safety. During our scheduled maintenance, trained certified arborists with APS will evaluate each tree to determine if pruning, or in some cases removal, is required to maintain clearance and reduce the risk of conflict. Trees scheduled for pruning will be marked with white paint. Trees designated for removal will be discussed with the property owner (or adjacent owner if in the county easement) and marked with red paint. Completion of the tree work will be performed by contract crews in marked vehicles and should occur between the months of June to October.

This vegetation management is part of our robust fire prevention measures. These measures include training for APS staff and contractors, possession of fire tools, and implementation of a fire watch/patrol in high risk situations. We have been in communication with the Apache Sitgreaves National Forest, along with your local fire responders, and they are supportive of APS's fire mitigation and prevention programs. APS is also passionate about tree care and the benefits of an urban forest. Part of our mission is educate and encourage our communities to convert landscapes into sustainable vegetation types that are compatible with electrical infrastructure following "Right Tree, Right Place" principles. As a result, APS has been recognized as a recipient of the Arbor Day Foundation's Tree Line USA Award each year since 1996.

APS appreciates the support of the Forest Lakes community to ensure the safe and reliable delivery of electricity to your community. We look forward to working as partners with you over the next couple of months. Water District

Office is currently closed. For Emergencies, please call 928-535-5438. Payments can be made by dropping them through the mail slot at the office, call the above number for a credit card payment, or mail to P. O. Box 1776, Forest Lakes, AZ 85931.

Library

School District Building

Building is closed until the Governor's Stay at Home and Social Distancing order is lifted. As things progress we will see how we can safely make accommodations that will be in the best interest of everyone involved.

U.S. Forest Service (Southwestern Region)

As of April 22, all fires are prohibited on the Apache-Sitgreaves National Forests and other National Forests in Arizona to protect the health and safety of employees and communities during the COVID-19 pandemic.

Coconino County Board of Supervisors Proclamation

Effective April 27, open burning of any kind is banned in Coconino County. This includes the Forest Lakes Community, an unincorporated subdivision in Coconino County.



Leave No Trace No Recommendations for Getting Outside During Covid-19

The coronavirus pandemic has altered all of our lives. The Leave No Trace Center for Outdoor Ethics aligns with the <u>CDC recommendations</u> to help slow the spread of the virus. Let's keep ourselves, our communities and our natural world healthy.

<mark>Y</mark>ou and Your Outdoor World

You may be asking: Can I go for a hike or walk on the beach right now? Your personal vulnerability, the health of others in your community, access to local and uncrowded spaces and more play into this decision. Then there are communities and states with either lockdown, shelter in place or stay at home mandates. Where Covid-19 is spiking, it may not be possible to get out at all, so pay close attention to guidance in your community before heading outside. Then follow physical distancing guidance, meaning staying at least six-feet away from anyone not living with you.

Expect Closures

As businesses limit services or direct their staff to work remotely, closures should be expected. The result could be a lack of water, restrooms, campgrounds, or other facilities—or even entire areas closed to the public. Many experts are recommending that you refrain from using public restrooms and other open facilities at all right now. Take necessary precautions like bringing extra food and water, learning how to go to the bathroom outdoors, and being ready to pack all your trash out with you.

Pack Out Your Trash

With limited staff and services likely in many parks and protected areas, trash and recycling receptacles may not be emptied as often as normal or at all. This can result in trash overflowing from receptacles which becomes litter and can harm wildlife. Instead, pack your trash and recyclables out with you all the way home and utilize your own receptacles.

Avoid Times and Places of High Use

Absolutely avoid crowded parks, trails, and beaches. Physical distancing applies in the outdoors just as it does anywhere else. To avoid being part of the creation of large crowds and groups at popular outdoor areas, spread out to less popular spots, and avoid times of highest use if possible. Follow guidelines at usa.gov/state-health about group size restrictions.

Proceed With Caution

Keep in mind that as our healthcare system becomes more overwhelmed, it's important to reduce potential accidents that would add to the stress on first responders and medical professionals. As much as possible, stick to activities and areas that are within your regular routine and take it easy.

Don't Forget the Leave No Trace 7 Principles

Just because times are tough, doesn't mean the Leave No Trace 7 Principles fly out the window. Our outdoor spaces will likely be receiving less attention from staff and volunteers right now. This means our shared spaces need us to act as stewards more than ever. Remember, it is still just as important to prepare for spring weather conditions, stick to trails, dispose of our waste properly, minimize fire impacts, leave what we find, keep a safe distance from wildlife, and generally do your best to eliminate impacts.

Be Considerate and Kind to Other Visitors

We are all in this together. Be considerate of others in the outdoors by ensuring that you practice physical distancing. Be particularly kind to park staff during these challenging times. Help them do their job by doing your part to take care of each other and our beloved outdoors.

Heading outdoors to get a break from being in the house?

We've adapted the T.R.E.A.D. Principles for social distancing outdoors to align with the recommendations from the CDC to help slow the spread of the disease and maintain physical and emotional health. Please help us keep the outdoors and enthusiasts healthy by following these easy guidelines.



Stay close to home and utilize less popular trails. If parking lots and trail heads are crowded, look for alternatives. If visiting a park or trail, remember to stay on designated routes.

Maintain a safe distance (6 feet minimum) from other recreationists. If you are feeling sick, stay home. Remember to keep hands clean. Keep sanitizer available in your vehicle or on your person. Avoid touching your face after being in public spaces.





Make sure your facilities are open before you head out and check for any travel restrictions. Follow local, state and Federal guidelines at usa.gov/state-health regarding restrictions on group sizes. To prevent overcrowding and protect people, many trails, parks and visitor centers are being shut down temporarily.

Keep members of local communities safe and healthy by avoiding places that are heavily affected by the virus or could be easily overwhelmed by medical emergencies.





Make sure to pack out what you pack in to keep places healthy and accessible for other users.
