PET BOARDING

Agreement

This contract (the "Agreement") is entered into between Duke's Black Dog Lodge, hereinafter referred to as the "Boarding Facility," "We," or "Our") and _____ (hereinafter referred to as the "Pet Owner," "You," or "Your") on _____ until _____ .

PET BOARDING SERVICES

The Boarding Facility agrees to provide pet boarding services (hereinafter referred to as the "Services") as stated on the client intake form in a professional, diligent, and responsible way. All Services will be compliant with the regulations of the pet boarding industry.

PET OWNER RESPONSIBILITIES

The Pet Owner must provide information that is accurate to the best of their knowledge about their pet(s). This includes disclosing any changes in their pets' health and behavior or any modifications to contact details that may be required while the Services are carried out. If the pet(s) have any known behavioral issues or aggression triggers, the Pet Owner must disclose these details to the Boarding Facility. The Boarding Facility has the right to refuse to provide the Services if the pet(s) have a contagious disease or display aggressive and dangerous behavior. The Pet Owner should ensure that there is a sufficient supply of pet necessities, including but not limited to pet food and medication (if applicable). These supplies should be sufficient for the entire duration of the Services.

PAYMENT AND FEES

The Pet Owner agrees to pay the Boarding Facility the fees as follows for the Services. The service fee is currently set at \$35 per day for one dog and an additional \$20 for each additional dog. The payment for the Services is due on or before the first day of Services, which is scheduled to begin on _____. If the payment is not made by the specified due date, a late payment fee of \$25 may be charged. In the event of non-payment, the Boarding Facility reserves the right to withhold or terminate services. The Pet Owner is responsible for any additional costs incurred while the Services are provided, including but not limited to veterinary expenses, transportation, special food or supplies, or other unforeseen expenses required for the well-being of the pet(s).

CANCELLATION AND TERMINATION

To cancel or alter services without incurring a cancellation fee, the Pet Owner is required to provide written notice at least 7 days prior to the planned commencement date. If a cancellation is made after this period, a cancellation fee of \$50 may be imposed. The Boarding Facility reserves the right to cancel or terminate services at any time due to reasons that may include but are not limited to aggressive pet behavior or medical necessities beyond our expertise. Should the Boarding Facility cancel the Services, the Pet Owner will be notified promptly, and a proportionate refund of any pre-paid fees will be provided. In case of termination, the Pet Owner commits to making arrangements for the care of their pet(s).

EMERGENCIES

In the event of a pet medical emergency or illness during the service period, the Boarding Facility will make every reasonable effort to contact the Pet Owner or their emergency contact immediately. If the Pet Owner cannot be reached in time, the Pet Owner authorizes the Boarding Facility to seek emergency veterinary care for their pet if necessary for the pet's health, safety, and well-being. The Pet Owner shall be responsible for all associated veterinary expenses.

CONFIDENTIALITY

The Boarding Facility should keep all of the Pet Owner's information (e.g., contact information, payment information, etc.) strictly confidential and agrees not to disclose it to any third parties without the explicit written consent of the Pet Owner.

LIABILITY

The Pet Owner agrees to indemnify and hold harmless the Boarding Facility from any claims, liabilities, damages, expenses (including legal fees), or harm to the pet(s) arising from the Services, except in cases of gross negligence or willful misconduct by the Boarding Facility.

ENTIRE AGREEMENT

This contract constitutes the entire agreement between the Pet Owner and the Boarding Facility regarding the Services and supersedes all prior discussions, understandings, representations, and agreements, both written and verbal.

FORCE MAJEURE

Neither party shall be held accountable for unforeseeable circumstances or events beyond their control, including acts of nature, government actions, war, epidemics, or other events hindering the contract's performance. The affected party must promptly notify the other party and make reasonable efforts to mitigate the event's effects.

SEVERABILITY

If any provision of this Agreement is found to be invalid, illegal, or unenforceable under applicable law, the invalidity, illegality, or unenforceability of such provision shall not affect the validity or enforceability of the remaining provisions of this Agreement.
No modification, amendment, or alteration of this Agreement shall be binding unless it is made in writing and duly executed by both parties. By signing below, both parties acknowledge and agree to the terms and conditions stated in this Agreement.
