Stalls are \$30/ day, and shaving \$13/ bale.

Fees: Entry fees for all classes except classics/ derby are \$30. Classic/ Derby prices are listed as follows: \$50/ \$500 Derby/ Classic, \$40/ \$250 Classic/ Equitation Challenge.

Payout for money classes: 1-30%, 2-20%, 3-15%, 4-13%, 5-12%, 6-10%

Hunter Derby 2'6", with 2'9" options, open to any rider/ horse combination. Cannot cross enter into 3' Derby with same horse or horse/ rider combination. Place to 6th, payout to 6th.

Hunter Derby 3', with 3'5" options, open to any rider/ horse combination. Cannot cross enter into the 2'6" Derby with same horse or horse/ rider combination. Place to 6th, payout to 6th.

Equitation Challenge, Open to ANY horse/ rider combination. Class is run until the last one is standing. When the judge deems appropriate she will call your number and ask that you excuse yourself from the ring. The judge can challenge the riders at any time on all things equitation. Examples, extension of stride, counter canter, collection, change of direction with or without a flying change, such a fun class! Place to 6th, payout to 6th.

Post Entry Fees: \$25/ horse if received after June 1st.

Adds/ Scratches: Same day adds must be done by 8:30 am to prevent the \$5/ add fee per class. **Scratches:** A scratch must be done before a class has started, otherwise you will be charged for that class.

Schooling: Free Ticketed rounds will be offered daily for \$30 each (purchased at the gate) tickets pre-purchased (before the show and are non-refundable) are \$20 each. **Hacking will be permitted in the mornings on show days.**

ALL LUNGING must be done in the Covered arena/ Arena 2. NO lunging will be permitted in the indoor arena at any time.

All In Horse Shows is following all the rules and regulations that UHJA requires, all classes on the schedule and class list that are asterisk (*) are NOT UHJA point classes. If you plan on riding in a UHJA medal class, you must be a member of UHJA. Forms will be available in the show office. All class requirements are located on the UHJA website under member resources.

1. EQUINE HEALTH AND WELFARE

Any horse on the show grounds with a fever of unknown origin or of suspicious origin must be reported to Horse Show Management and to the Show Veterinarian. Isolation stalls will either be available on the grounds or at a local veterinary practice if the need arises.

Please take the time to review equine hygiene practices. Please convey the importance of this to your equine caretakers for their daily routines.

2. RELEASE, ASSUMPTION OF RISK, WAIVER AND INDEMNIFICATION GR908

This document waives important legal rights. Read it carefully before signing. **I AGREE** in consideration for my participation in this Competition to the following: **I AGREE** that the "Federation" and "Competition" as used above includes all of their officials, officers, directors, employees, agents, personnel, volunteers and affiliated organizations. **I AGREE** that I choose to participate voluntarily in the Competition with my horse, as a rider, driver, handler, vaulter, loungeur, lessee, owner, agent, coach, trainer, or as parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death ("Harm"). **I AGREE** to hold harmless and release the Federation and the Competition from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm of any nature caused by me or my horse to others, even if the Harm arises or results, directly or indirectly, from the negligence of the Federation or the Competition. **I AGREE** to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the Federation or the Competition. **I AGREE** to indemnify (that is, to pay any losses, damages, or costs incurred by) the Federation and the Competition and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse while at the Competition. I have read the Federation Rules about protective equipment, including GR801 and, if applicable, EV114 and I understand that I am entitled to wear protective equipment without penalty, and I acknowledge that the Federation strongly encourages me to do so while WARNING that no protective equipment can guard against all injuries. If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and **AGREE** to all of the above GR9 - PRIZE LISTS © USEF 2016 || provisions and **AGREE** to assume all of the obligations of this Release on the child's behalf. I represent that I have the requisite training, coaching and abilities to safely compete in this competition. **I AGREE** that if I am injured at this competition, the medical personnel treating my injuries may provide information on my injury and treatment to the Federation on the official USEF accident/injury report form. BY SIGNING BELOW, **I AGREE** to be bound by all applicable Federation Rules and all terms and provisions of this entry blank and all terms and provisions of this Prize List. If I am signing and submitting this Agreement electronically, I acknowledge that my electronic signature shall have the same validity, force and effect as if I affixed my signature by my own hand.

3. HORSE SHOW COMMITTEE AND MANAGEMENT

The Horse Show Committee reserves the right to interpret all questions and conditions in regard to or arising out of, or incident to the show without claims for damages or recourse of any kind. All questions not covered in these Rules and Regulations shall be decided by the Horse Show Management; its decision to be final.

The Horse Show Management reserves the right to limit entries in any class, section or division, to refuse, accept conditionally, or to cancel any entries, disqualify any riders or exhibitors, prohibit exhibition of entries, and cancel award prizes, without any claim for damages; to change any course, to add a dotted line, to cancel or combine any unfilled classes, or to reschedule classes, after due notice to exhibitors; to change rings or rotate judges; to change specifications in jumper classes as competition warrants. Every horse entered herein for competition will be under the control of the Horse Show Management, but the Show Management will in no case be responsible for any loss or damage that may occur, and it shall be a condition of entry that each exhibitor shall hold the horse show and the officials, employees, directors, officers, sponsoring entities of the horse show and the facilities at which the horse show is held blameless for any loss or accident to his horse(s), employee(s), or equipment which may occur from sickness, fire or other cause.

4. COMPETITION OFFICE HOURS

Competition Days: Office opens one hour before the start of the first class and closes 30 minutes following the last class. Non-Competition Days: 1:00 PM - 5:00 PM

5. ENTRIES

The closing date for entries of the All In Hunter Jumper show is **June 1st**. Entries received at the show will be charged a late fee of \$25. Entries should be submitted through Horseshowtime, or can be mailed

to the address located on the entry form. **Numbers WILL NOT be issued without a SIGNED OPEN CHECK/ and or Credit Card on file logged with the Horse Show Secretary.** The entry form for each show must include the following:

6. .DEPOSIT:

VALID CREDIT CARD MUST BE ON FILE TO ENTER. CREDIT CARD WILL NOT BE CHARGED UNTIL JUNE 11th, CHECK MAY BE PROVIDED AT CLOSE OF SHOW TO AVOID CREDIT CARD PROCESSING.

4.FEE SCHEDULE

Mandatory office/grounds fee of \$12/ day. Arenas will be available for schooling the day prior to the first day of competition. Please refer to schedule for schooling times and heights.

Post Entry Fee. Regular fees will be charged for all post entries plus a \$25/ horse Post Entry Fee.

A check returned for any reason will incur a \$50 Returned Check Fee.

Horses scratched from the show will be charged a \$75 Scratch Fee. Horses scratched from the show before the closing date will receive a full refund. Scratching special classes AFTER 5PM the day prior to the class results in forfeiture of all entry fees.

on-Showing Horse Fee: Non showing horses will pay a \$25 non-showing horse fee.

Convenience Fee: all accounts closed with a credit card will pay a 5% per entry convenience fee

7. ADDED CLASS POLICY

ALL ADD/DROPS WILL BE PERFORMED BY EXHIBITOR OR TRAINER ON

HORSESHOWTIME.COM PRIOR TO 5PM ON THE EVE OF SHOW DAY TO AVOID PENALTY

Please note that a \$10 charge per class will be added for Day-of-Adds as we encourage riders/trainers to add classes the day prior at no charge to allow for more accurate scheduling. Day-of-Adds will be based on schedule availability and management approval. There is no guarantee that Day-of-Adds will be accepted. Featured Classes: Horses entering the same day may be required to go first and will pay the entry fee and a \$10 post entry fee.

8. CAVEAT DUE TO UNCERTAINTY

All Hunter Classics with prize money require 6 entries to fill and complete or the classes may be combined or cancelled

All Jumper Classes with prize money require 6 entries to fill and complete or the class may be combined or cancelled

9. ACCIDENTS INVOLVING COMPETITORS USEF GR1316.2

In the event of a fall/accident where the competitor is apparently unconscious or concussed, he/she is precluded from competing until evaluated by qualified medical personnel as defined in GR1211.5. If the competitor refuses to be evaluated, he/she is disqualified from the competition.

RULES AND REGULATIONS: I hereby agree to be bound and abide by the rules, regulations, and policies of USEF as published in the USEF Rule Book and on the website at www.usef.org, as amended from time to time. B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers (u201cRisks(u201d).
