

# Black Dog Investigations: Informed Consent & Service Agreement

## I. Scope of Practice & Methodology

Black Dog Investigations (BDI) operates on a strict metaphysical framework based on historical Nahua (Aztec) principles. We are not ghost hunters, mediums, or entertainers. We are Diagnostic Specialists and Resolution Practitioners.

**Nature of Services:** These services are religious, spiritual, and metaphysical in nature.

**I Am Not a Licensed Professional:** I am not a physician, psychologist, psychiatrist, licensed counsellor, or any other state-licensed health-care provider. I do not diagnose or treat medical or mental-health conditions, and I never advise anyone to discontinue prescribed medication or medical treatment.

## II. Environmental Pre-Requisites (The Tlazolli Clause)

Service is contingent upon a safe and clean environment. In the Nahua framework, physical filth (Tlazolli) acts as a food source and anchor for parasitic entities.

**Hoarding & Sanitation:** The client agrees that the property must be free of significant clutter, hoarding, animal waste, or biological hazards.

**Right of Refusal:** BDI reserves the right to terminate the investigation immediately if the property is found to be in a state of squalor or hoarding. In such cases, the deposit is non-refundable.

## III. Media, Recording, & Confidentiality Policy

This is a private clinical intervention, not a media event.

**The Media Blackout:** No third-party media crews, journalists, or documentary filmmakers are permitted on-site during the active investigation or resolution phases.

**Client Recording:** The client agrees **NOT** to photograph, video record, or livestream any part of the diagnostic sweep or resolution ritual without the express, written permission of the Practitioner.

**Our Records:** BDI may record audio/video for internal diagnostic use. These records remain confidential and will not be shared publicly without Client consent.

## IV. The 'One Shot' Mandate

We work towards definitive resolution.

**Compliance:** The client understands that 'Resolution' requires strict adherence to the Practitioner's post-operative instructions (e.g., maintaining a seal, refraining from spirit board use).

**Relapse:** Failure to follow these instructions may result in the return of the entity. BDI is not liable for recurrence caused by client non-compliance.

## V. Financial & Refund Policy

All payments are final and non-refundable once the session begins.

**Definition of 'Session Start':** The session officially begins the moment I leave my location to travel to you (for on-site visits) OR the moment we connect for a scheduled remote/Zoom/phone session—whichever comes first.

**Pre-Payment Rules:** On-site diagnostics and restoration services require full or partial payment in advance. Remote sessions require payment prior to the scheduled call.

### Non-Refundable Triggers:

- Once payment is received and I begin travel to your location, the session is considered started and the payment is non-refundable.
- Remote sessions become non-refundable the moment the scheduled call connects or I begin reviewing any materials you have sent.

**Cancellations:** If you cancel before I leave my location (on-site) or before the remote call connects, any payment minus actual expenses already incurred (travel fuel, prep time, etc.) may be refunded at my sole discretion on a case-by-case basis. There are no automatic refunds.

**Extenuating Circumstances:** Serious illness, death in the family, etc., are reviewed individually. Clients must email [blackdoginvestigationstx@gmail.com](mailto:blackdoginvestigationstx@gmail.com) as soon as possible.

## VI. Consent to Enter & Release of Liability

Protection for the Practitioner and Team.

This release explicitly covers

premises-related claims, slip-and-fall accidents, property damage, or personal injury incurred during the investigation.
