The Following changes are **effective from December 31, 2024** pursuant to the **Amendment brought in by SEBI on December 12, 2024**:

1. The outcome of Board Meeting, wherein unaudited financials and limited review report of the statutory auditor was approved, shall be given as per the following timeline:

a. **Within 30 minutes:** If the board meeting closes during the trading hours or not more than 3 hours before the opening of next trading day. b. **Within 3 hours:** if the board meeting ends after normal trading hours but at least three hours before the start of the next trading day's normal hours.

2. The Listed Entity has below two options for **publication of financials in newspaper**:

a. Publish **completed financials** as it used to do before the Amendment or

b. Publish a **QR Code** and the details of the webpage where complete financial results along with the adverse opinion of the Auditor are accessible.
