# EXAMINING SURGEON'S CERTIFICATE

I hereby certify That etc have carefully examined this applicant, who claims that while in the service of the United States, at or near a place named Lewis Bluff Ark, and while in line of duty, on or about the 1st day of March, 1865, he incurred Rheumatism of scurvy, and that in consequence thereof he is 1 disabled for earning his subsistence by manual labor.

Cause of disability and the degree.

Particular description.

He states that he is 50 years of age, that he weighs 135 pounds, and that he is 5 feet 7 inches in height.

His pulse-rate per minute is 73, his respiration 14, and his temperature normal

The examination reveals the following facts:

No symptoms or signs of scurvy -  
There is slight mental insufficiency (depression) also hypertrophy of left ventricle,  
1/4 Rating - no other indications of rheumatism

Give the rational and physical signs so fully that how and why and how much the claimant is disabled shall clearly appear. When there are neither structural changes nor physical nor rational signs in support of the claim, that fact should be stated. The rating should be made in compliance with the "Instructions."

Sec. 4, Act July 27, 1852. "That all examinations shall be thorough and searching, and the certificate contain a full description of the physical condition of the claimant at the time, which shall include all the physical and rational signs and a statement of all structural changes. The fee for such examination and satisfactory certificate shall be two dollars, &c., &c. No certificate will be considered satisfactory, or such examination paid for, unless the above requirements of the law are satisfied."

It must be borne in mind that the duty of the Surgeon is to give an opinion as to the proportionate degree of disability, as a total, &c., through the grades, without any regard to dollars and cents, and to make such a full particular description as will afford to this office the ground for intelligent opinion and action in rating.

From the condition and history of the claimant, it is my opinion the disability was incurred in the service as claimed, and that it is not aggravated or protracted by vicious habits.

I find the disability as above described to entitle him to 1/4 rating.
