Minn Vol Reg't in 1864 & 1865; I know and remember the above named claimant Archibald Rose. He contracted Rheumatism in March 1865 at Duval's Bluff Ark in the service and in the line of duty. He was sick in Regimental Hospital of the same, and was under my care and treatment. He continued to suffer to some extent of the disease, and was only able to perform light duty during the remainder of his term of service. He was discharged in July 1865 and was suffering of the disease at that time. I make this statement from memory.

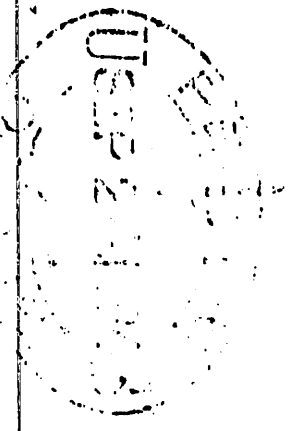
