- 3. Approval of the minutes from Feb. 2021
  - A. As amended to include
    - a) Update to include E. Election Committee "Holly is not present to accept the nomination"

- 4. Construction updates Tracey
  - A. We had Hernandez Elec out today, they worked most of the day replacing the Elec Subpanel in the Cattery. They will give us a hard bid for the main service panels and a couple other items such as powering the back kennels
  - B. Completed our portion of the kennel roof, the beam is up so we are ready for the roofers
  - C. Had a nice walk around with Paul Shimmins, as soon as we can give him some hard numbers. He is also for sure taking care of the \$10K electric for Hernandez Elec; he has room for a little more.
  - D. Asked if Austin Pets was coming still, we are sure they are not coming in march as Planned because of their weather.
  - E. Jenny has been in contact with Darleen, we have a tentative date of March 20 but they are waiting for the steel delivery
  - F. On a side note, during our printer assessment, we were informed the 2 sheds we put up between the Dog Office and the Cattery is now blocking the signal for the internet
- 5. Treasurer report Jenny
  - A. Kether, we had a finance meeting, and jenny has some great reports put together and the LPL statement
  - B. We were are seeing increase, we were at 1,003,259 and our current statement is at 1,024,819
    - a) YTD Income \$125,112
    - b) YTD Expenses \$105,756
    - c) Network for good check \$5,844.00
    - d) Paypal \$894.86
    - e) Checking \$183,812
    - f) LPL Investment \$1,024,819

- C. We did have a slight over look last month, and the Shady Brady check was split, what we received is all we will receive. With that said, we will run a deficit this year of \$40K which we will work to make up through fundraising
  - a) Our vet expenses is really high, we are at \$19K now, Kether asked if Jenny knows how much we have raised in comparison to how much we have spend, Jenny is hoping to track that, but is just hasn't had the time.
- D. We are in Mid March and at \$30K for Vet expenses. We will need to try a little more aggressively to raise money for specific veterinarian costs.
- E. Clover device, charges a 3.5% fee; we received a promotional email that we could ask the customer to pay the fee, instead of HSIMC being charged for it. Jenny didn't see where it was an option for each person but a "HSIMC charge" or "Customer charge" We are charged the least amount for a debit charge. Higher fees for Discover and Amex, Midrange is Visa/Mastercard and the least charge for is the Debit.

- a. Steve from Ray Morgan company has been coming on site for the last couple weeks. He provided this really nice powerpoint presentation. Jenny provided a lot of information for the analysis, going with this company and having two printers, one in the cattery and one in the dog office with a 48 month contract, paying \$279 per month. Even with this monthly charge, he estimated we would still be saving almost \$2K. He looked over our AT&T phone bill, and we are paying \$380 for our phone line and our fax line. We rarely get faxes and only send one fax for our monthly Science Diet order. The printer would be set up to email what we would essentially fax. And turn the fax line in to a second phone line.
- b. Tracey asked if that is something we will vote on, Kether said this would have to go out in email for official business.
