Public input: Leif Christiansen from Sonoma Clean Power (SCP)

Commercial account manager. 2 yrs with SCP and before that with PG&E SCP is a non-profit. Majority of power sourced from renewable energy.

Excess revenue is banked in reserve to keep rates stable for customers and provide incentives

Rates generally 7% below PG&E

Customers can opt in or out once every 12 months

85% of residential and commercial customers in Sonoma and Mendocino county

Several mayors and BoS members are on the board

Renewable resources produce the power then delivered thru PG&E lines

Incentives for solar power

Healdsburg and Ukiah have their own power utilities.

Clean Power and EverGreen renewable energy

Resources for customers – energy center in Santa Rosa

Did a usage review of HSIMC PG&E billing, we could have saved about \$1,500 over the past year.

Community giving program provides rebates, incentives and grants to non-profits.

If we switch over to SCP, they will perform a free energy analysis

Shelter Operations – Pretty short staffed the month of February

New employee – Sara (Please stop by and introduce yourself) – Rafael no longer with the shelter

Safety of volunteers – longer stays are causing anxiety in dogs and bite incidents

Moving animals in and out of kennels causes more incidents

Increased levels of fear and anxiety in long term animals

Suggested to add more information on volunteers to shelter ops report

Share more information about long term animals who get adopted

Staff training has been very successful
